COMPULSORY PURCHASE OF LAND IN CHICKERELL, WEYMOUTH, DORSET

CONSTRUCTION OF A NEW HIGHWAY

Notice is hereby given that the County Council of Dorset has made The County Council of Dorset (Chickerell Link Road) Compulsory Purchase Order 2004, and The County of Dorset (Chickerell Link Road) (Side Roads) Order 2004, under the Highways Act 1980. It is about to submit these orders to The Secretary of State for Transport for confirmation and if confirmed, the orders will authorise The County Council of Dorset to purchase compulsorily the land described below for the purpose of the construction of a new highway.

A copy of the orders and of the accompanying maps may be seen at all reasonable hours at County Hall, Colliton Park, Dorchester DT1 1XJ, and Council Offices, Weymouth and Portland Borough Council, North Quay, Weymouth DT4 8TA.

THE COUNCIL OF THE COUNTY OF SOMERSET (NORTH WEST TAUNTON TRANSPORT PACKAGE A38/A3065) (SIDE ROADS AND OTHER WORKS) ORDER 2003

The Secretary of State for Transport hereby gives notice that he has confirmed the above Order which was made by the Council of the County of Somerset under sections 14 and 125 of the Highways Act 1980, and which, as confirmed, authorises the Council to:

- (a) improve lengths of highways;
- (b) stop up highways;
- (c) construct new highways;
- (d) stop up private means of access to premises; and
- (e) provide new means of access to premises,

all on or in the vicinity of the route of the classified road which the Council are proposing to improve from a point 78 metres south of the centreline of Waterfield Drive to its junction with Waterfield Drive, from a point 33 metres south of the centreline of Meadowside Close to a point 180 metres north of the centreline of Heron Drive, from a point 265 metres north of the centreline of Heron Drive to a point 270 metres south of the centreline of Bindon Road, to construct from the last mentioned point in a generally northerly direction to a point 120 metres south of the centreline of Bindon Road and to improve from the last mentioned point in a northerly direction to a point 215 metres north of the centreline of Bindon Road.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Highways Act 1980 or on the ground that any requirement of that Act or of any regulations made thereunder has not been complied with in relation to the Order, may, within 6 weeks of 3 September 2004, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
