# **Road Traffic Acts**

## London Borough of Southwark THE GRANGE (CPZ 'GR') CONTROLLED PARKING ZONE

1. Notice is hereby given that the Council of the London Borough of Southwark on 1 September 2004 made the London Borough of Southwark (Waiting Restrictions and Parking Places) (CPZ 'GR') Traffic Order 2004 under sections 6, 45, 46, 51 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended. The Order will come into force on 3 September 2004 and will continue the effects of the London Borough of Southwark (Waiting Restrictions and Parking Places) (CPZ 'GR') Experimental Traffic Order 2003 which expired on that date.

In brief, the general nature and effect of the Order will be to continue the controlled parking zone (known as CPZ 'GR') in the area bounded on the north by Druid Street and the railway line (London Bridge to South Bermondsey), on the west by Tower Bridge Road, on the south by Old Kent Road and generally on the east by Rouel Road (north of Spa Road), Dunlop Place, Vauban Street, Alscot Road, Henley Drive and Dunton Road, but including Chaucer Drive, Humphrey Street, Longfellow Way, Lynton Road (west of Balaclava Road), Mandela Way, Milton Close, Oxley Close, Southwark Park Road (west of Balaclava Road) and Spa Road (west of Ness Street). The Order will continue to provide:

(a) parking places on the streets specified in Schedules 1 to 6 of this notice and a loading bay on the street specified in Schedule 7 to this notice;

(b) that the vehicles which may use the parking places and loading bay while they are in operation will be those described at the beginning of each Schedule (and the classes of the vehicles described in Schedules 1, 2 and 3 of this notice will be passenger vehicles (having 8 passenger seats or less), certain goods carrying vehicles, motor cycles and invalid carriages):

(c) that the parking places on the streets specified in Schedules 1, 2, 3 and 4 of this notice and the loading bay on the street specified in Schedule 7 to this notice will operate between 8.00 am and 6.30 pm on Mondays to Fridays, the parking places specified in Schedules 5 and 6 of this notice will operate at all times;

(d) that permits will be issued, on payment of the appropriate charge, to a person who is the keeper of a vehicle of a class referred to in subparagraph (b) above and providing:

(i) in the case of a resident's permit, that they are a resident of any street within the controlled parking zone (maximum of three resident's permits will be issued per household);

(ii) in the case of a business permit, that they have a business in any street within the controlled parking zone;

(iii) in the case of a visitor's permit, that they are a resident of any street within the controlled parking zone and that such permit is to be used by a bona fide visitor to their home:

(iv) in the case of a doctor's permit, that they are a qualified medical doctor practising at a surgery within any street within the controlled parking zone.

(e) that the charge for a pay and display ticket referred to in Schedule 2 to this notice will be at the rate of 20 pence for 10 minutes (£1.20 per hour) and vehicles displaying such a ticket may use certain parking places in the streets specified in paragraph (1) of that Schedule for a maximum period of 1 hour and certain parking places in the streets specified in paragraph (2) of that Schedule for a maximum period of 4 hours, with no return to the parking place within 2 hours of leaving it; (f) that charges for permits will be as follows:

(i) for a resident's permit for a vehicle other than a motorcycle: £8, £22, £40 and £76 for 1, 3, 6 and 12 months respectively and for motorcycles: £19 for 12 months;

(ii) for a business permit: £65, £130 and £255 for 3, 6 and 12 months respectively (12 monthly resident's and business permits will also be available for 'environmentally friendly vehicles' at a discounted charge of £19 and £63.75 respectively);

(iii) for a doctor's permit: £76 for 12 months;

(iv) for a visitor's permit: £12 for the first book of 10 permits and after that £30 for each subsequent book of 10 permits;

(g) that there will be no charge for the use of the parking places or loading bay specified in Schedules 4, 5, 6 or 7 of this notice;

(h) that vehicles displaying a disabled person's badge will be permitted to use the parking places specified in Schedule 1 or 2 to this notice without charge or time limit:

(i) that new restrictions on waiting by vehicles will apply in the controlled parking zone either between 8.00 am and 6.30 pm on Mondays to Fridays (zone hours) or at any time.

3. A copy of the Order and other documentation giving more detailed particulars of the Order are available for inspection during normal office hours until 6 weeks from the date on which the Order was made at Southwark Regeneration and Environment Department, Council Offices, Chiltern House, Portland Street, London SE17 2ES.

4. If any person wishes to question the validity of the Order or of any of its provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984, or that any requirement of that Act or of any instrument made under that Act has not been complied with, that person may, within 6 weeks from the date on which the Order is made, apply for the purpose to the High Court. #### SCHEDULE ]

Streets on which parking places are provided for the use of vehicles displaying either a resident's permit or a visitor's permit:

Grange Walk (between Fendall Street and Tower Bridge Road) and Neckinger (between Abbey Street and Grange Walk).

#### SCHEDULE 2

Streets on which parking places are provided for the use of vehicles displaying either a resident's permit, a business permit, a visitor's permit or a pay and display ticket purchased from a ticket parking meter:

 Fendall Street, Grange Walk and Neckinger; and
Abbey Street, Aberdour Street, Alscot Road, Alscot Way, Chaucer Drive, Crimscott Street, Curtis Street, Dunton Road, Enid Street, The Grange, Hendre Road, Henley Drive, Leroy Street, Longfellow Way, Long Walk, Lynton Road, Maltby Street, Marcia Road, Millstream Road, Oxley Close, Page's Walk, Purbrook Street, Pope Street, Riley Road, Setchell Road, Spa Road, Tanner Street, Webb Street and Willow Walk.

SCHEDULE 3

Street on which a parking place is provided for the use of vehicles displaying a doctor's permit:

### Alscot Road.

SCHEDULE 4

Streets on which parking places are provided for the use of motor cycles:

Alscot Road, Crimscott Street, Enid Street, The Grange, Grange Walk, Leroy Street, Maltby Street, Riley Road, Spa Road and Willow Walk.

Streets on which parking places are provided for the use of vehicles displaying a disabled person's badge, in accordance with the regulations relating to the use of such a badge:

Aberdour Street, Alscot Road, Lynton Road and Neckinger.

SCHEDULE 6

Street on which a parking place will be provided for the use of ambulances: Grange Walk.

#### SCHEDULE 7

Street on which a loading bay is provided for the use only of goods vehicles that are being loaded or unloaded for periods of not more than 30 minutes at a time, with no return to the loading bay within 2 hours of leaving it :

The unnamed road lying at the side of The Grange public house, Grange Road.
