##### TOWN AND COUNTRY PLANNING ACT 1990

#### TOWN AND COUNTRY PLANNING ACT 1990, SECTION 249

The Secretary of State for Transport hereby gives notice that he has made an Order entitled "The Extinguishment of Vehicular Rights (County of Hampshire) (No 4) Order 2004", with regard to highway at High Street, Andover, Hampshire.

This Order comes into operation on 3 November 2004, and extinguishes any rights which persons may have to use vehicles (other than those specified in Schedule 2 to the Order) on the highway described in Schedule 1 to the Order.

If any person aggrieved by the Order desires to question its validity, or the validity of any provisions contained in it, on the ground that it is not within the powers conferred by the Act or that any requirements of that Act, or of any regulations made under it, has not been complied with in relation to the Order, he or she may, within 6 weeks from 3 November 2004, apply to the High Court for the suspension or quashing of the Order or of any provision contained in it.

Unless the Order is suspended or quashed as a consequence of any such application, any person who, on 3 November 2004, had an interest in land having a lawful access to the highway to which the Order relates may claim to be entitled to be compensated by Test Valley Borough Council in respect of any depreciation in value of his or her interest which is directly attributable to the Order and of any other loss or damage which is so attributable. Any claim must be served on Test Valley Borough Council, Beech Hurst, Weyhill Road, Andover, Hampshire SP10 1LJ, within a period of 6 months from 3 November 2004, unless the period is extended in any particular case by the Secretary of State.
