NOTICE PURSUANT TO SECTION 116 AND PART 1 OF SCHEDULE 12 OF THE HIGHWAYS ACT 1980

1. Portsmouth City Council hereby gives notice, pursuant to section 116 and Part 1 of Schedule 12 of the Highways Act 1980, of its intention to apply to Portsmouth Magistrates Court on 23 December 2004, for an Order to stop up the highway detailed in paragraph 1.1 below.

1.1 Portsmouth City Council intends to apply for an Order to stop up an area of the highway formerly known as Part of Southampton Road, Paulsgrove, adjacent to the former Johnson & Johnson factory. The total area of the public highway to be closed is 1.097 hectares being a maximum length of 323.5 metres and a maximum width of 87.2 metres each measurement being taken from the back of the highway pavement.
