The Secretary of State for Transport hereby gives notice that he proposes to make an Order under section 247 of the above Act, which will authorise the stopping-up of an area of highway at Barley Close, Southgate, Crawley in the county of West Sussex.

This replaces the previous notice and proposed Order published on 5 January 2005. Anyone who objected to the previously published Order and wishes their objection to stand will need to resubmit the objection in the normal way outlined below.

If the Order is made, the stopping-up will be authorised only in order to enable the development described in the Schedule to this notice to be carried out in accordance with the planning permission granted to Crawley Borough Council, c/o Property & Procurement Services, Crawley Borough Council on 23 September 2003, by Crawley Borough Council under Ref CR/2003/0520/RG3, and with the planning permission granted to Crawley Borough Council, c/o Calfords Seaden on 9 November 2004, by Crawley Borough Council under Ref CR/2004/ 0684/FUL.
