- (1) authorise him to provide for the exclusive use of traffic of Classes I and II of the classes of traffic set out in Schedule 4 to the Highways
- (a) a special road ("the motorway") along a route described in Schedule 1 to the Order and
- (b) connecting special roads to connect the motorway with other highways described in Schedule 2 to the Order;
- (2) provide for [each of] the new special road[s] to become a trunk road [insofar as it will consist of newly constructed road] on the date when the Scheme comes into force

- 2. An Order under section 18 of the Highways Act 1980 which will provide that each length of trunk road described in the Schedule to the Order, and which is comprised in the route of a special road which he proposes to provide in accordance with the M6 Motorway (Carlisle to Guards Mill Section) and Connecting Roads Scheme 2005, shall be appropriated as part of that special road from the date on which that road is first open for use as a special road/the works authorised by the M6 Motorway (Carlisle to Guards Mill Section) (Side Roads) Order 2005 have been completed.
- 3. An Order under section 10 of the Highways Act 1980, entitled The A74 Trunk Road (Carlisle to Guards Mill Section) (Detrunking) Order 2005, which:
- (1) provides that roads which he proposes to construct along the following routes shall become trunk roads from the date when the Order comes into force:
- (a) a route ("the main route") about 8.6 kilometres in length from the existing end of the M6 Motorway at Junction 44 Greymoorhill, to the beginning of the A74 (M) at Gretna.
- 4. An Order under sections 10 and 12 of the Highways Act 1980 which will provide that the length of the trunk road to be superseded by the new trunk road on the main route described in 3(1)(a) above shall cease to be a trunk road and shall be classified as a classified road, as from the date on which the Secretary of State notifies Cumbria County Council (who will become the highway authority responsible for that length) that the new trunk road on the main route is open for traffic.
- 5. An Order under sections 12, 18 and 125 of the Highways Act 1980, in relation to the part of the M6 Motorway which will be situated between Carlisle and Guards Mill in the county of Cumbria which will:
- (1) authorise him to-
- (a) improve highways,
- (b) stop up highways,
- (c) construct new highways,
- (d) stop up private means of access to premises, and
- (e) provide new means of access to premises,
- all in the vicinity of the route of the motorway mentioned in 3(1)(a) above; and
- (2) provide for the transfer of each new highway to the Cumbria County Council as highway authority as from the date on which he notifies them that it has been completed and is open for traffic.
