Notice is hereby given that the Council of the Royal Borough of Kingston upon Thames, on 18 April 2005, made the following Orders under sections 6 and 124 of the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985, in connection with the revitalisation of the Ancient Market Place:

The Kingston upon Thames (Prescribed Routes) (No 2) Traffic Order 2005:

The Kingston upon Thames (Waiting and Loading Restriction) (Special Parking Area) (Amendment No 10/2005) Traffic Order 2005;

The Kingston upon Thames (Free Parking Places) (Disabled Persons) (Special Parking Area) (Amendment No 28) Traffic Order 2005; and The Kingston upon Thames (Free Parking Places) (Goods Vehicles) (Special Parking Area) (Amendment No 18) Traffic Order 2005.

- 2. The general effect of the Orders, which will come into force on 25 April 2005, would be to continue in force indefinitely the provisions of The Kingston upon Thames (Prescribed Routes) (No 3) Experimental Traffic Order 2003; The Kingston upon Thames (Waiting and Loading Restriction) (Special Parking Area) (Amendment No 31/2003) Experimental Traffic Order 2003; The Kingston upon Thames (Free Parking Places) (Disabled Persons) (Special Parking Area) (Amendment No 21) Experimental Traffic Order 2003; and The Kingston upon Thames (Free Parking Places) (Goods Vehicles) (Special Parking Area) (Amendment No 15) Experimental Traffic Order 2003 to:
- (a) prohibit all vehicles from entering or proceeding in certain lengths of Church Street, Market Place and Thames Street at all times, except:
- (i) for the purposes of gaining access to premises within the restricted area between 7.00 am* and 10.00 am and between 4.00 pm and 6.00 pm on Mondays to Saturdays only;
- (ii) pedal cycles proceeding in the western arm of Market Place/
- (iii) emergency service vehicles, authorised refuse collectors, statutory undertakers, and vehicles being used in connection with weddings or funerals at All Saints Parish Church;

(*market traders will be permitted to enter the area from 6.00 am)

- (b) remove the existing restrictions on access to the northern section of Church Street (Memorial Square) and Union Street (between Church Street and the southern boundary of No 23);
- (c) change the hours of the existing single yellow line restrictions, so that waiting will be prohibited "at any time" throughout the restricted area; (d) introduce disabled persons' parking places, at which vehicles displaying a disabled person's badge may be left between 8.00 am and 10.00 pm, Monday to Saturday and between 12.00 noon and 5.00 pm on Sundays without charge or time limit, in:

Bishop's Hall (approximately 4 spaces on the south side); Church Street/Memorial Square (approximately 7 spaces); Thames Street (approximately 5 spaces outside Nos 23 to 29); and

- (e) introduce a disabled persons' parking place, at which vehicles displaying a disabled person's badge may be left between 8.00 am and 10.00 pm throughout the week without charge or time limit, in Union Street (approximately 3 spaces outside No 9);
- (f) introduce goods vehicle parking places, at which goods vehicles may be left without charge for a maximum parking period of 30 minutes between 7.00 am and 7.00 pm throughout the week (with no return within 1 hour), in:

Church Street/Memorial Square (adjacent to No 23); Thames Street (west side, south of Clarence Street); and Union Street (west side, outside No 21).

Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to the Order may make application for the purpose to the High Court by 31 May 2005.
