DESIGNATION OF THE DUDLEY TOWN CENTRE CONSERVATION AREA AND THE REVISED BOUNDARY OF THE CASTLE HILL CONSERVATION AREA

NOTICE IS HEREBY GIVEN that by Resolution dated 17 March 2005, the Dudley Metropolitan Borough Council designated as the Dudley Town Centre Conservation Area the area of Dudley Town Centre described in the Schedule below and revised the designated boundary of the existing Castle Hill Conservation Area to include the addresses listed on the Castle Hill Conservation Area Schedule below, in pursuance of sections 69 and 70 of the Planning (Listed Buildings and Conservation Areas) Act 1990.

An effect of the new designations is that the former Priory Street Conservation Area and the former boundary of the Castle Hill Conservation Area are now superseded.

The Conservation Areas have been designated because Dudley Metropolitan Borough Council has determined that they are areas of special architectural or historic interest, and it is desirable to preserve or enhance their character or appearance.

The principal effects of designation as a conservation area are as follows:

1. The Council is under a duty to prepare proposals to ensure the preservation and enhancement of the area.
2. Consent must be obtained from the Council for the demolition of any building in the area (subject to limited exemptions).
3. Six weeks' notice must be given to the Council before works are carried out to any tree in the area.
4. Special publicity must be given to planning applications for development in the area.
5. In carrying out any functions under the planning Acts (and, in particular, in determining applications for planning permission and listed building and conservation area consent) the Council and the
