The Secretary of State for Transport hereby gives notice that he proposes to make the following Orders:

- 1. An Order under sections 10, 41, 106 of the Highways Act 1980 which will:
- (1) provide that roads which he proposes to construct along the following route shall become trunk roads form the date when the Order comes into force:
- (a) Provide a new 2.9 km length of single carriageway trunk road from a point on the existing A69, 200 metres west of the junction to West Rattenraw in the county of Northumberland, proceeding in a southeasterly direction, then north-easterly, to a point on the existing A69 Trunk Road, 180 metres east of the existing A69/A686 junction.
- An Order under sections 10 and 12 of the Highways Act 1980, which will provide that a length of the A69 Trunk Road to be superseded by the new trunk road on the main route shall cease to be a trunk road, and shall be classified as a classified road, as from the date on which the Secretary of State for Transport notifies Northumberland County Council (who will become the highway authority responsible for that length) that the new trunk road on the main route is open for traffic.
- An Order under sections 12, 14 and 125 of the Highways Act 1980, in relation to the A69 Trunk Road and the new trunk road to be constructed by him at Haydon Bridge in the county of Northumberland, which will:
- (1) authorise him to:
- (a) improve highways,
- (b) stop up highways,
- (c) construct new highways,
- (d) stop up private means of access to premises,
- (e) provide new means of access to premises,
- all in the vicinity of the new road on the main route; and
- (2) provide for the transfer of each new highway to Northumbria County Council as highway authority as from the date on which he notifies them that it has been completed and is open for traffic.

Copies of each draft Order and the plans referred to in it, and of the environmental statement which the Secretary of State for Transport has published in relation to the construction of the new highways and the improvement of an existing highway referred to in the draft Orders numbered 1, and 3 above, may be inspected, free of charge, at all reasonable hours from 14 June 2005 until 6 September 2005, or within 12 weeks from the date of first publication of this notice if that period expires later, at the Highways Agency, Room 710, City Tower, Piccadilly Plaza, Manchester M1 4BE, and at the offices of Tynedale District Council, Hadrian House, Market Street, Hexham, Northumberland; Northumberland County Council, County Hall, Morpeth, Northumberland NE61 2EF; and Haydon Bridge Library, Church Street, Haydon Bridge, Northumberland NE47 6JQ.

Any person may object to the making of any of these Orders not later than 6 September 2005 or within 12 weeks from the date of first publication of this notice if that period expires later, by notice to the Secretary of State for Transport at the offices of the Highways Agency, Major Projects Division, Room 710, City Tower, Piccadilly Plaza, Manchester M1 4BE, quoting Ref HA/065/30/141 and stating the grounds of objection.
