

*Flags, Aug. 15.* The States of the Province of Holland will assemble here To-Morrow. M. Preiss, the Swedish Secretary here, is made Resident, and has delivered his Credentials to the States. He is ordered to negotiate a Loan of a Million of Crowns, for which the Revenues of the Province of Goetland; in which Gottenburg is situate, and the Customs collected at that Place, are offered to be mortgaged: The Earl of Cadogan returned hither last Night from Amsterdā.

Whitehall, August 11, 1719.

And whereas notwithstanding the Advertisements of the 12th and 15th of January 1717, and repeated Letters and Precepts since, for the Colonels of the several Regiments that served in Spain and Portugal, or their Agents, to lay before us the Accounts of their respective Regiments for our settling and determining the same, they still neglect to comply with our Orders: This is to give Notice, that if the said Accounts are not laid before us on or before the 1st of September next, we will look upon such Neglect as an Acquiescence in the Charges made upon their Regiments by the Paymaster General, and shall proceed in stating the Accounts of those Regiments accordingly.
