5. Six weeks' notice must be given for planning applications for development in the said Conservation Area as varied;

6. Consent must be obtained from the said Council (subject to certain exceptions) to cut down, top, lop, uproot, wilfully damage or wilfully destroy any tree in the said Conservation Area as varied.
