Take notice that Caprice Holdings Ltd, 28-30 Litchfield Street, London WC2H 9NL, are applying to the Environment Agency for a licence to abstract water from the Upper Chalk at National Grid Ref TQ 2841 8060 at Scott's Restaurant, 20-22 Mount Street, London W1K 2HE. The proposals are to abstract water at the following rates, 18 cubic metres per hour, 342 cubic metres per day and 123,462 cubic metres per annum. The water will be used all year round for the purpose of building air-conditioning and operating refrigeration equipment. All abstracted water will be discharged back to the Chalk aquifer with a maximum temperature differential of 10 deg Celsius via a second borehole at National Grid Ref TQ 2839 8059, in accordance with a consent issued by the Environment Agency discharge office.

NOTICE OF APPLICATION FOR A LICENCE TO ABSTRACT WATER

Take notice that the Royal Society for the Protection of Birds (RSPB) of The Lodge, Sandy, Bedfordshire SG19 2DL, is applying to the Environment Agency for a licence to abstract water from the Nant Berw at National Grid Ref SH 466 725 at Pentre Berw, Anglesey, North Wales.

The proposal is to abstract 50 per cent of the Nant Berw flow at any time less a residual of 2 litres per second, up to maximum rates of 2.2 thousand cubic metres per hour, 53 thousand cubic metres per day, and 1,075 thousand cubic metres per year.

The water will be used to sustain water levels in existing wetland areas and create additional wetland habitats in the Malltraeth Marsh RSPB Reserve.
