

2. The general effect of the Order would be to:

- (a) introduce waiting restrictions "at any time" throughout the week at junctions or sections of the streets specified in the Schedule to this notice;
- (b) introduce loading restrictions "at any time" throughout the week in Lower Addiscombe Road (outside Nos 336 to 374) and Shirley Road (outside Nos 5 to 7);
- (c) introduce waiting restrictions in Queen Mary Road at its junction with Crown Dale which would operate between 8.00 am and 6.30 pm Monday to Saturday inclusive; and
- (d) introduce two additional 1-hour maximum stay free parking bays in Colliers Water Lane.

3. This is to improve visibility for motorists emerging from junctions and to allow pedestrians crossing minor roads to see and be seen and reduce obstructive parking so that turning vehicles have sufficient manoeuvrability.

DOCTOR'S PARKING PLACE, DEVONSHIRE ROAD, CROYDON

1. Notice is hereby given that the Croydon Council propose to make the Croydon (Doctor Parking Places) (No D1) Traffic Order 2006 under sections 45, 46, 49 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985.

2. The general effect of the Order would be to:

- (a) designate a doctor's parking place in Devonshire Road, Croydon for use by legally qualified medical practitioners, and to apply the provisions of the Croydon (Doctor Parking Places) (No 2) Order 1975, to the parking places so designated;
- (b) provide that vehicles displaying a permit issued under the Order may be left in this parking place;
- (c) provide that this parking place would be in operation between 8.00 am and 8.00 pm on any day of the week;
- (d) provide that a permit may be issued by Croydon Council on application being made by a legally qualified medical practitioner; (note, permits in respect of the parking places will be issued only in connection with the medical practices conducted at premises specified in column 2 of the Schedule to this notice).
- (e) provide that the charge in connection with the issue of permits for the use of the parking place would be £220 and that the permits would be valid for a period not exceeding 12 months;
- (f) specify that the provisions of the Order of 1975 shall apply generally to the parking place.

TEWKESBURY TERRACE, CLOSURE AT ITS JUNCTION WITH TELFORD ROAD (A406 NORTH CIRCULAR ROAD)

1. Notice is hereby given, that the Council of the London Borough of Enfield made the Enfield (Waiting and Loading Restriction) (Special Parking Area) (Amendment No 255) Order 2006 and the Enfield (Prescribed Routes) (No 2) Traffic Order 2006 under sections 6 and 124, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Waiting and Loading Order will be to introduce new "At any time" waiting restrictions in the area of Tewkesbury Terrace immediately south-east of the closure, to prevent obstructive parking and provide a turning area for vehicles.

3. The general effect of the Prescribed Routes Order will be to prohibit vehicles from entering or leaving Tewkesbury Terrace at its junction with Telford Road (A406).

(NOTE: the existing footway at the north-western end of Tewkesbury Terrace will be re-aligned and bollards emplaced to reinforce the closure.

4.
