If you wish to question the validity of the Order, or of any provision contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act, 1984, or on the grounds that any requirement of the Act or of any Instrument made under it has not been complied with in relation to the Order you may, within 6 weeks from 30 January 2006, being the date the Order was made, apply to the High Court for this purpose.
