Highways Agency **ROAD TRAFFIC REGULATION ACT 1984** THE A404 TRUNK ROAD (MAIDENHEAD THICKET TO HANDY CROSS) (CLOSURE OF LAYBY) ORDER 2006

The Secretary of State for Transport hereby gives notice that he made the above-named Order under sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on 24 February 2006, coming into force on 13 March 2006, on the A404 Trunk Road at Handy Cross in the borough of Wycombe in the county of Buckinghamshire.

The effect of the Order is to close the layby on the northbound carriageway of the trunk road, which extends for approximately 110 metres south from a point 80 metres south of where the trunk road crosses Winchbottom Lane at Handy Cross, High Wycombe in Buckinghamshire.
