THE Deputies which this Canton sent last Summer to Laufane to visit that Academy, suspected here of several Errors in Matters of Religion, have begun to make their Report to the Senate or Little Council; but it is thought the Opinion of the moderate People of this State will be followed, who are for dropping entirely this Matter, as the best Means to preserve Peace amongst the Clergy of this Country.

Hague, Dec. 26. The States General having some Days ago dispatched an Express to Madrid, with a Letter to the King of Spain, notifying their Accession to the Treaty of Quadruple Alliance with all its secret and separate Articles; their High Mightinesses did on the 23d Instant proceed to order the following Placart to be published.

THE States General of the United Netherlands, to all who shall see these presents, or hear them read, Greeting: Whereas of late Complaints have been made to us on the Part of the Powers engaged in the War against Spain, touching the sending of Contraband Goods to Spain, notwithstanding that by the Treaties of Navigation and Commerce subsisting between some of those Powers and us, the Subjects of this State are prohibited from supplying their Enemies with Contraband Goods; and it being our Intention faithfully to observe and perform the said Treaties, and thereby to prevent all Inconveniencies and Troubles that might arise from the Breach of them; we have therefore thought fit to direct and order, as by these Presents we do direct and order, that no Subject of this State or any other Person, shall export or cause to be exported out of these Provinces, to any Place in the Domini-

ons of the King of Spain, any Goods or Merchandize which by the Treaties between us and some of the Powers, engaged in the War against Spain, are declared to be Contraband, and are specified in the said Treaties; on the Penalty to those who shall offend herein, of Forfeiture not only of all such Contraband Goods, but also of the full Value thereof over and above; and likewise of a Fine of 2000 Guilders to be paid by the Masters and Owners on whose Ships such Contraband Goods shall be laden.

Their High Mightinesses did likewise on the 23d Instant, give Direction for sending this Placart to the several Chambers of Admiralty, with strict Orders to see to the putting it in Execution. And that the same may not be eluded on Pretence of sending such Contraband Goods to Portugal, Italy, or other Parts in the Neighbourhood of Spain, the said Chambers of Admiralty are charged not to suffer any Contraband Goods to be exported for those suspected Countries without taking Security of the Exporters, for double the Value, that the said Goods shall be carried to and unladen at the Places for which the same are declared to be shipped; proper Certificates of which their Unlading shall, within a convenient Time to be limited by the said Chambers of Admiralty, according to the Distance of the respective Places, be produced by the Exporters, in Default of which Process is to be issued against them.

This Proceeding of the States General for preventing the supplying Spain with Contraband Goods, is the more taken Notice of, because during the late War against France and Spain, their High Mightinesses could not be prevailed upon, by all the Instances that were made to them on the Part of their Allies, to publish any such Placart.

Paris, Dec. 27. By Letters of the 11th Instant from Madrid it is advised, that Cardinal Alberoni was to depart that City the next Day the 12th. The King's Pleasure had been signified to the foreign Ministers, to address themselves to the Marquess Grimaldo. The other Secretaries of State were continued. His Catholick Majesty seemed not inclined to employ a first Minister any more in the Administration, and had appeared in Publick accompanied by the Grandees, and the Queen attended with a Circle of Ladies of the first Rank; both which had been a long time discontinued, almost from Cardinal Alberoni's entering upon the Administration. There are Letters from Italy which advise, that the Imperial Convoiy was failed from Messina for Trapani; and from Leghorn it is advised, that the Pope continued to be very ill that his Life was despaired of.

Navy-Office, Dec. 18, 1719.

The Right Honourable the Lords of the Treasury having appointed Monday for paying of Half Pay to Sea Officers in the 30th of June 1719, according to His Majesty's Establishment on that behalf; these are to give Notice, that the said Payments will begin to be made at the Treasurer of the Navy's Office in Broad-Street; on Tuesday the 29th Instant, for the Captains; Wednesday the 30th for the Lieutenants; and Thursday the 31st Instant for the Masters; that all Persons concerned may then and there attend to receive what shall become payable to them, and not only bring with them the Affidavits required touching their not having enjoyed the Benefit of any publick Employment whatsoever, either at Sea or on Shore, during the time they are to be paid the said Half Pay, but also produce Certificates (if they have not already done it) that they have subscribed the Test, and taken the Oaths required by the late Act of Parliament; and in case any of the said Officers shall not be able to attend themselves to receive their Money, but employ Attornies for that Purpose, that the said Attornies may produce the like Certificates and Affidavits from the Persons they are employed by.

Whereas several Sorts of Goods, as wearing Apparel, Plate, Watches, Rings, Jewels, &c. have been pledged to Mr. Richard Preety, lately at the Three Bows in Little Newport-Street, by Oraborn-Alley, and since at the Three Bows in Vere Street, by Clare-Market: This is to give Notice to all Persons, having any Right or Claim to any of the Goods aforesaid, that if they do not fetch them away before the 28th of February next, they will be disposed of, he having left off his Business, and the House is to be Lett.
