and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984 as amended by the Road Traffic Act 1991.

2. The general effect of the Hammersmith and Fulham (Free Parking Places) (Disabled Persons) (Amendment No 4) Order 2006, which will come into effect on 25 September 2006, will be to amend the Hammersmith and Fulham (Free Parking Places) (Disabled Persons) (No 479) Order 2005, so as to designate further free parking places for vehicles displaying a valid disabled person's blue badge at the locations as described in the notice of proposal published in the local and London Gazettes on 25 August 2006.

3. The general effect of the Hammersmith and Fulham (Waiting and Loading Restriction) (Consolidation) (Amendment No 1) Order 2006, which will come into effect on 25 September 2006, will be to amend the existing Hammersmith and Fulham (Waiting and Loading Restriction) (Consolidation) (No 510) Order 2006, so that waiting restrictions would apply to sections of those roads as specified in Schedule 1 to this notice. 4. The general effect of The Hammersmith and Fulham (Parking Places, Zone O) (Amendment No 1), which will come into effect on 25 September 2006, will be to amend The Hammersmith and Fulham (Parking Places, Zone O) (No 422) Order 2004, by adding the parking places specified in Schedule 2 to this notice.
