ROAD TRAFFIC REGULATION ACT 1984

THE A64 TRUNK ROAD AND THE A1079 TRUNK ROAD (GRIMSTON BAR INTERCHANGE) (40 MILES PER HOUR SPEED LIMIT)

NOTICE IS HEREBY GIVEN that the Secretary of State for Transport proposes to make an Order under Sections 84(1)(a) and (2) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, on the A64 Trunk Road and the A1079 Trunk Road in the District of the City of York.

The effect of the Order, if made, will be to impose a 40mph speed limit on the A1079 Grimston Bar Interchange Roundabout, and on the following lengths of A64 slip road connected to that roundabout:

- (i) the northbound exit slip road from 65 metres south of its junction with the roundabout;
- (ii) the northbound entry slip road from its junction with the roundabout for 10 metres;
- (iii) the southbound exit slip road from 65 metres north of its junction with the roundabout; and
- (iv) the southbound entry slip road from its junction with the roundabout for 10 metres.

THE BARNET (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. ***) TRAFFIC ORDER 200*

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet propose to make the above-mentioned order under Sections 6 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 and all other enabling powers.

The general effect of the above Order would be to introduce new waiting and loading restrictions in the borough, as follows:

- 1. New Monday to Saturday 7am to 7pm waiting restrictions would be introduced on both sides of Plantagenet Road, New Barnet between the existing waiting restrictions near its junction with Station Road, and its junction with Leicester Road in order to ease traffic congestion in Plantagenet Road. The introduction of the waiting restrictions would alleviate the current obstructive parking which occurs and would therefore improve traffic flow.
- 2. The existing 'At Any Time' waiting restrictions on the north-eastern side of Orange Hill Road from its junction with Watling Avenue would be extended by 12.0 metres in order to ensure access to a new bus stop area in Orange Hill Road.
- 3. The existing peak-hours waiting and loading restrictions on Burnt Oak Broadway in the vicinity of the Edgware Community Hospital would be upgraded to 'At Any Time' waiting and loading restrictions following the development of the hospital which included the construction of an entrance road. The 'At Any Time' restrictions, would, in conjunction with new road markings and other measures, prevent parking, including by those with disabled badges which would improve road safety and traffic flow.
- 4. New 'At Any Time' waiting restrictions would be introduced in Colney Hatch Lane between its junctions with the two arms of Poplar Grove in order to ease traffic congestion and improve traffic flow on this busy bus route. The introduction of waiting restrictions would also improve sightlines for vehicles exiting Poplar Grove onto Colney Hatch Lane.
- 5. New Monday to Saturday 7am to 7pm waiting restrictions would be introduced in Poplar Grove in order to allow the free flow of traffic and improve road safety on Poplar Grove.
