1 Abington Road, N3; 61 Addison Way, NW11; 91 Bertram Road, NW4; 53 Bow Lane, N3; 19 Churchfield Avenue, N12; King Street N2, for No. 42 Church Lane, N2; 22 Cornwall Avenue, N3; 47 Cranbrook Road, East Barnet; 41 Glebe Road, N3; 11 Hadley Highstone, Barnet; 15 Hadley Highstone, Barnet; St. Mary's Avenue (side of No. 68 Hendon Lane, N3); 22 Herbert Road, NW9; 1 Leicester Road, N2; 7 Parklea Close, NW9; 33 Silkstream Road, Burnt Oak; 15 Underne Avenue, N14; 8 Westholm, NW11; 3 Woodville Road, Barnet. The bays at 91 Bertram Road, NW4, 19 Churchfield Avenue, N12, 22 Cornwall Avenue, N3, 22 Herbert Road, NW9 and 1 Leicester Road, N2 would be provided by converting an existing parking space. It is also proposed to remove the following redundant disabled parking bays, and where noted convert to free or permit parking spaces:

3 Beresford Road, N2 (convert to permit parking space), 56 Babington Road, NW4 (convert to permit parking space), 60 Bertram Road, NW4 (convert to permit parking space), 10 Bohun Grove, East Barnet, 60 Brookside South, East Barnet, 3 Claverly Grove, N3 (convert to permit parking space), 2 Dukes Avenue, N3 (convert to permit parking space), 89 Durham Road, N2 (convert to permit parking space), 38 Glenthorne Road, N11, Hastings Close, New Barnet, (one bay), 81 Hillview Gardens, NW4, 101 Pembroke Road, N10, 3 Summit Way, N14, 14 Trinity Road, N2, 36 Wentworth Road, Barnet, 4 Wellgarth Road, NW11 (convert to free parking space), 110 Woodfield Drive, East Barnet, 17 Woodside Grove, N12 (convert to permit parking space). The designated bay No.001 at No. 747 Finchley Road, NW11, would be removed, and replaced with more proposed and proposed propose removed and replaced with waiting and loading restrictions operative Monday to Friday 4.00pm to 7.00pm.

## THE BARNET (LOADING PLACES) TRAFFIC ORDER 200\*

NOTICE IS HEREBY GIVEN that the Council of the London Borough of Barnet propose to make the above-mentioned Orders under Sections 6, 45, 46 and 49 of the Road Traffic Regulation Act 1984 and all other enabling powers.

In order to address the congestion that occurs in certain roads adjacent to the existing HC2 Controlled Parking Zone (CPZ) in Hendon it is proposed to include the following roads or lengths of road as part of the HC2 CPZ: Sunningfields Road down as far as, but not including Sunny Hill Court, Sunny Gardens Road between the existing CPZ boundary and the common boundary of Nos. 52 and 54 Sunny Gardens Road, Nursery Walk, Fuller Street, and Rowsley Avenue between its junction with Sunny Gardens Road and the common boundary of Nos. 1 and 3 Rowsley Avenue.

The existing HC2 CPZ operates Monday to Friday 10am to 5pm, and this HC2 extension would operate for the same hours, providing parking places which indicate by the appropriate signage their use during the controlled hours by vehicles displaying either a valid residents' permit, visitor voucher, business permit, disabled persons blue badge or a pay and display ticket as appropriate. Loading and unloading would be permitted in these parking places without the need to display a permit, visitor voucher or pay and display ticket for up to twenty minutes, provided that the loading and unloading was seen to be continuous. Where parking places are not being provided yellow line restrictions would be introduced in all lengths of road in the relevant area which would restrict parking during the hours that the CPZ operates. As part of the CPZ it is also proposed to introduce "At Any Time" waiting restrictions at the following locations:

- in Fuller Street opposite Nos. 29 to 37
- in Sunningfields Road outside Nos. 30 to 34, No. 5, Nos. 48a to 54, Clarice Court to No. 23, Nos. 31 to St Annes Court and Nos.98 to 100
- in Sunny Gardens Road outside Nos. 19 to 25, Nos. 32 to 34, Nos.
- 49 to 53 and outside The Garden Hospital
- in Rowsley Avenue outside No. 1 and Nos. 2 to 8

which would prohibit parking at all times to maintain traffic flow, especially for emergency vehicles. For the same reasons, "At Any Time' waiting restrictions are also being proposed at the junction of Downage and Sherwood Road, at the bend in the road opposite No. 1 Downage, at the junction of Nursery Walk and Sunningfields Road, at the junction of Nursery Walk and Sunny Gardens Road, at the junction of Rowsley Avenue and Sunny Gardens Road, at the junction of Meadow Drive and Sunny Gardens Road and at the junction of Fuller Street and Sunny Gardens Road.

Holders of disabled persons blue badges and motorcycles are exempt from all parking charges. Resident permits cost £40 per year for the first vehicle and £70 each for the second and third vehicles. A maximum of three permits can be purchased per household. Visitor vouchers cost £10 per book of ten vouchers, and a maximum of 20 books per household per year. Business permits cost £300 per year with a maximum of three permits per business. HC2 permits and visitor vouchers are valid throughout the whole HC2 area.

The fees for pay and display parking would be:-

Up to 15 minutes	£0.30
Up to 30 minutes	£0.50
Up to 45 minutes	£0.80
Up to 1 hour	£1.50
Up to 90 minutes	£2.50
Up to 4 hours	£3.00 *
Over 4 hours	£4.00

\* some pay and display bays will have a maximum stay period of 4 hours. The maximum stay permissible will be indicated by appropriate signage.
