### THE BEXLEY (WAITING AND LOADING RESTRICTION) (AMENDMENT NO ) TRAFFIC ORDER 200X

The Council also propose to introduce speed tables and pedestrian crossings which are being advertised separately.

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley propose to make the above mentioned Order under sections 6, 84, and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by Section 8 of and Part 1 of Schedules 5 and 9 to the Local Government Act 1985.

2. The general effect of the Bexley (Waiting and Loading Restriction) (Amendment No ) Traffic Order 200X would be to further amend the Bexley (Waiting and Loading Restriction) Order 2002 so that:—

Additional "At any time" waiting restrictions are introduced in Briary Court, Sidcup; Durham Road, Sidcup; Lincoln Road, Sidcup; Oxford Road, Sidcup; and Sidcup Hill, Sidcup.

#### THE BEXLEY (CRAYFORD) (PARKING PLACES) (AMENDMENT NO ) TRAFFIC ORDER 200X

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Bexley propose to make the above-mentioned Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985.

2. The general effect of the Bexley (Parking Places) (Disabled Persons) (Amendment No ) Traffic Order 200X would be to:—

(a) designated parking places in which vehicles authorised by the Order may be left for a period during the permitted hours without charge in the roads specified in the Schedule to this Notice;

(b) provide that the parking place will operate at any time throughout the week;

(c) specify, in respect of the parking places in the roads in the Schedule, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Orange/Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) Regulations 1982, may be left therein;

(d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g. to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc; and

(e) the existing parking places in Abbey Road, Bexleyheath; Clarence Crescent, Sidcup; Harding Road, Bexleyheath; Horsa Road, Bexleyheath; and Thursland Road, Foots Cray; are revoked.

3. The general effect of the Bexley (Crayford) (Parking Places) Traffic Order 1998 (and the Orders that have amended that Order); would be to amend an existing parking place in Waterside, Crayford so that two disabled bays can be provided.
