Any person desiring to question the validity of any of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to any of the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

DISABLED PERSONS PARKING PLACES – SCHEDULE 118

1. NOTICE IS HEREBY GIVEN that Croydon Council propose to make a Traffic Order under section 6 of the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Croydon (Free Parking Places) (Disabled Persons) (No. B3) Traffic Order 2007 would be to:

(a) revoke the disabled parking places outside Nos. 32 and 34 Addison Road, South Norwood, (reverting back to a 'pay and display' bay), outside No. 7 Beaumont Road, Upper Norwood, outside No. 25 Belmont Road, South Norwood, outside No. 57 Dalmally Road, Croydon, outside No. 227 Davidson Road, Croydon, outside No. 87 Frant Road, Thornton Heath, outside No. 6 Gilsland Road, Thornton Heath, (reverting back to a 'pay and display' bay), outside No. 59 Lancing Road, Croydon, outside No. 55 and outside No. 69 Laurel Crescent, Shirley, outside No. 237 Long Lane, Croydon, outside No. 258 Lower Addiscombe Road, Croydon, outside No. 176 Norbury Court Road, Norbury and outside No. 28 Westbourne Road, Croydon;

(b) designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit outside Nos 3 and 5 Addison Road, South Norwood (converting a 'pay and display' bay), outside No. 87 Bygrove, New Addington, outside No. 73 Cecil Road, Croydon, outside the Methodist Church, Elmers Road, South Norwood (2 bays), outside No. 118 Frant Road, Thornton Heath, outside No. 105 Gonville Road, Thornton Heath, outside Nos. 46 and 48 Goston Gardens, Thornton Heath, outside No. 57 Lyndhurst Road, Thornton Heath, outside Nos. 58 and 60 Nutfield Road, Thornton Heath, outside No. 20 Oakhill Road, Norbury, outside No. 5 Westbourne Road, Croydon, outside No. 36 Woodlands Grove, Coulsdon and outside No. 23 Woodside Avenue, South Norwood.

3. A copy of the proposed Order and of all related Orders, of the Council's statement of reasons for proposing to make the Order and of the plans which indicate each length of road to which the Order relates, can be inspected during normal office hours on Mondays to Fridays inclusive until the last day of a period of six weeks beginning with the date on which the Order is made or, as the case may be, the Council decides not to make the Order, at the Enquiry Counter, 'One-Stop' Facility, Ground Floor, Taberner House, Park Lane, Croydon, Surrey.

ROAD TRAFFIC REGULATION ACT, 1984, SECTION 14 AS AMENDED BY SECTION 4 (7) OF SCHEDULE 5 TO THE LOCAL GOVERNMENT ACT 1985 AND THE ROAD TRAFFIC (TEMPORARY RESTRICTIONS) ACT 1991

FELL ROAD, GEORGE STREET, HIGH STREET, CROYDON, KATHARINE STREET, PARK LANE AND PARK STREET, CROYDON

TEMPORARY PROHIBITION OF PEDESTRIAN AND VEHICULAR TRAFFIC

1. Croydon Council HEREBY GIVE NOTICE that to facilitate works in the highway associated with the Park Place development they have made an Order the effect of which will be to temporarily prohibit pedestrian and vehicular traffic movements in Fell Road, George Street, High Street, Croydon, Katharine Street, Park Lane and Park Street, Croydon.

2. Whilst the said works are taking place:

(a) no person shall cause any vehicle:

(i) proceeding in St George's Walk to turn right into Park Street; (This prohibition affects buses, taxis and cycles only)

(ii) to proceed in Park Lane, that length of carriageway connecting the southbound and northbound carriageways of Park Lane, the bus bridge, which lies between its junctions with George Street and Park Street;

(b) a one-way working would be introduced in Katharine Street:

(i) in a south-westerly direction, between its junctions with Park Lane and Fell Road;

(ii) in a south-westerly direction, between its junctions with Fell Road and High Street, Croydon;

(These one-way workings will be introduced at different stages of the work)

(c) no person shall proceed along the public footway which lies on:

(i) the south-east side of George Street West, between Nos. 16 and 20 George Street West and between Nos. 36 and 42 George Street West;

(ii) the north-west side of Park Street, between St. George's Walk and Park Lane;

(d) 6 'pay and display' parking bays in that part of Fell Road south of Mint Walk will be converted to disabled parking bays with a 3 hour maximum stay limit;

(e) the existing limited time disabled bays in Fell Road between Katharine Street and Mint Walk will be suspended to locate a bus stand;

(f) the south-eastbound bus lane in Park Lane bus bridge imposed by the Croydon (Bus and Tram Priority) (No. 1) Traffic Order 2004 will be suspended;

(g) the goods vehicle loading bay in High Street, Croydon imposed by the Croydon (Goods Vehicle) (Free Parking Places) (No. 1) Traffic Order 2002 will be suspended;

(h) the taxi cab rank in High Street, Croydon, the west side, outside Nos. 2 and 4 High Street, Croydon imposed by the Croydon (Prohibition of Stopping on Cab Ranks) (No. 1) Traffic Order 2005 will be suspended.

3. Whilst the works are taking place the alternative routes are as follows:

(a) in the case of 2(a) (i) above via Katharine Street and Park Lane;
