#### **NOTICE OF INCREASE IN ADDITIONAL PARKING CHARGES**

Following a determination by the London Councils Transport and Environment Committee, the Mayor of London and Secretary of State for Transport have approved the following additional parking charges to take effect in the London boroughs from the 1st July 2007.

The introduction of differential parking penalties introduces two levels of charges payable for a Penalty Charge Notice. As such, the charges issued within the London borough of Hammersmith and Fulham, will increase on the above date to:

For parking penalties at the higher rate:

£120 (Band A) reduced to £60 if paid within 14 days from the date of issue of the Penalty Charge Notice.

£100 (Band B) reduced to £50 if paid within 14 days from the date of issue of the Penalty Charge Notice (applies to Harrow Road, Old Oak Common Lane and Old Oak Common Road only).

For parking penalties at the lower rate:

£80 (Band A) reduced to £40 if paid within 14 days from the date of issue of the Penalty Charge Notice.

£60 (Band B) reduced to £30 if paid within 14 days from the date of issue of the Penalty Charge Notice (applies to Harrow Road, Old Oak Common Lane and Old Oak Common Road only).
