Council of the City of Newcastle upon Tyne ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14 (AS AMENDED)

CITY OF NEWCASTLE UPON TYNE (GALLOWGATE) TEMPORARY TRAFFIC REGULATION ORDER 2007

- 1. NOTICE IS HEREBY GIVEN that the Council of the City of Newcastle upon Tyne intend, not less than twenty one days from the date of this Notice, to make an Order the effect of which will be to—(a) suspend the existing eastbound 'no car' lane on Gallowgate located from a point 10 metres west of Strawberry Lane eastwards for 82 metres.
- (b) to introduce a 'no car' lane on Gallowgate (eastbound offside lane) from a point 16 metres west of Percy Street westwards for 36 metres.
- 2. For the purpose of the Order "car" means a mechanically propelled vehicle, not being a motor cycle or an invalid carriage or a licensed hackney carriage or private hire vehicle or being constructed or adapted for use for the conveyance of goods or burden of any description, which is constructed itself to carry not more than seven passengers and their effects and of which the weight unladen does not exceed 3050 kilograms.
- 3. The Order is required in connection with works to be carried out on or near the highway in respect of the Eldon Square redevelopment. 4. The Order will come into operation on 1 July 2007 and will continue for in force for longer than 18 months, as and when the relevant traffic signs are displayed, until the proposed works are completed. Once the works are completed, the Order will be revoked. It is anticipated that the works will be completed by approximately Easter 2010.

THE A556 TRUNK ROAD (BUCKLOW HILL LANE JUNCTION) (LEFT TURN ONLY) ORDER 200*

NOTICE IS HEREBY GIVEN that the Secretary of State for Transport proposes to make an Order under Sections 1(1) and 2(1) and (2) of the Road Traffic Regulation Act 1984, on the A556 Trunk Road (Chester Road) in the District of Macclesfield, in the County of Cheshire.

The effect of the Order, if made as proposed, will be to prohibit any vehicle from making any manoeuvre other than a left turn into the A556 Chester Road from its junction with Bucklow Hill Lane.

This prohibition will not apply to vehicles being used for emergency purposes by the police, fire and rescue or ambulance services, or anything done at the direction of, or with the permission of, a police officer in uniform.

convert existing residents' bays to short stay (1 hour) parking bays 09.00-17.30 Monday to Friday inclusive in Lyndhurst Road and Rudland Road, Barnehurst.

The proposal, the Bexley (Barnehurst)(Parking Places)(Amendment No...) Traffic Order 200X and, the Bexley (Bexleyheath)(Parking Places)(Amendment No...) Traffic Order 200X was part of the measure for the Barnehurst and Bexleyheath CPZ. The Council has decided to introduce these measures under Section 19 of the Local Authorities' Traffic Orders (Procedures)(England and Wales) Regulations 1996.

3. The general effect of the Bexley (Bexleyheath)(Parking Places)(Amendment No. 12) Traffic Order 2007 would be to further amend the Bexley (Bexleyheath) (Parking Places) Traffic Order 1998 would as to:—

change the use of an existing disabled parking space in Abbey Road, Bexleyheath to a residents' parking space.
