##### ROAD TRAFFIC REGULATION ACT 1984

##### THE LEWISHAM (PROHIBITION OF STOPPING OUTSIDE SCHOOLS) (AMENDMENT NO. 7) TRAFFIC ORDER 2007

##### THE LEWISHAM (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 106) TRAFFIC ORDER 2007

1. NOTICE IS HEREBY GIVEN that Lewisham Council made these two orders under the provisions of section 6 of the Road Traffic Regulation Act 1984 on the 6 July 2007. Both orders come into force on the 23 July 2007.

2. The general nature and effect of the two orders order is, respectively, by amendment to their parent orders, to—

- (a) introduce No Stopping Mondays to Fridays 8 to 9.30 am. and 2.30 to 4.30 pm. prohibition on yellow 'zig-zag' markings at St. Joseph's Vale west side outside St. Matthew Academy school entrance, 43.5 metre length between 39 and 82.5 metres north of Lee Terrace; and
- (b) alter waiting restrictions at St. Joseph's Vale to No Waiting At Any Time east side within 12 metres and west side within 14 metres of Lee Terrace.

3. Exemptions from the restrictions include vehicles stopping to avoid an accident, ambulance, fire brigade and police vehicles in an emergency and anything done with the permission or at the direction of a police constable in uniform.

4. Documents giving more detailed particulars of the orders and measures can be inspected between the hours of 10am. and 4pm. on Mondays to Fridays at the office of Lewisham Highways Development, Wearside Service Centre (Door-to-door Building), Wearside Road, Ladywell, London, SE13 (tel. 020-8314 2265).

5. Any person wishing to question the validity of either order or of any of their provisions on the grounds that it or they are not within the powers conferred by the Road Traffic Regulation Act 1984 or that any requirement of that Act or of any instrument or relevant regulation made under the Act has not been complied with may, within 6 weeks from the date on which the order was made, apply for the purpose to the High Court.

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent propose to make the above mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Road Traffic Act 1991.

2. The general effect of the 'Disabled Persons Parking Places' Order would be to revoke the Brent (Free Parking Places) (Disabled Persons) (No. 5) Order 2007 and to:—

- (a) designate parking places in certain lengths of the streets specified in the Schedule to this Notice in which vehicles authorised by the Order may be left for any period without charge;
- (b) provide that the parking places would operate "at any time";
- (c) specify, in respect of the parking places, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Blue Badge") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 may be left therein;
- (d) provide that certain vehicles may wait in the parking places in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc;
- (e) relocate the designation of parking places outside No. 16 All Souls Avenue, NW10 and No. 41 Tennyson Road, NW6.

3. The general effect of the 'Parking Places Amendment' Orders would be to revoke the Brent (Parking Places) (No. 5, 2001) (Amendment No. 3) Order 2007, the Brent (Parking Places) (No. 2, 2004) (Amendment No. 2) Order 2007, the Brent (Parking Places) (No. 3, 2004) (Amendment No. 2) Order 2007, the Brent (Parking Places) (No. 9, 2004) (Amendment No. 1) Order 2007 and the Brent (Parking Places) (No. 9, 2004) (Amendment No. 1) Order 2007 and to reduce in length and redefine existing resident parking places in association with the provision of disabled persons parking places in Chapter Road, Cooper Road, Honeywood Road, Kempe Road, Montrose Avenue and Tennyson Road.

4. The general effect of the 'Free Parking Places Amendment' Order would be to revoke the Brent (Free Parking Places) (No. 1, 2007) (Amendment No. 1) Order 2007 and to reduce in length and redefine an existing free parking place in association with the provision of a disabled persons parking place in Church Road.

5. A copy of each of the proposed Orders, of relevant Orders of 2001 and 2004 (and of the Orders which have amended those Orders) and 2007, of the Council's statement of reasons for proposing to make the Orders and of maps which indicate each length of road to which the Orders relate can be inspected during normal office hours on Mondays to Fridays inclusive until the expiration of a period of 21 days from the date on which this notice is published at:—

- (a) The One Stop Local Office, Brent Town Hall, Forty Lane, Wembley, Middx, HA9 9HX; and
- (b) The One Stop Local Office, Brent House, 349 - 357 High Road, Wembley, Middx, HA9 6BZ.
