NOTICE IS HEREBY GIVEN, that the Council of the London Borough of Camden propose to make the above-mentioned Orders under Sections 6 and 124 of, and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

The changes to the Orders will be;-\*To make approximately 34 parking spaces in the 3 lay-bys in Pancras Road for passenger vehicles to set-down passengers for a short-term, maximum stay 2 minutes. Drivers not to leave their vehicles unattended. \*To provide 4 additional spaces for disabled persons vehicles to setdown passengers for a short-term, maximum stay 5 minutes.

\*To make Pancras Road, from Euston Road to Goodsway/Camley Street northbound to all vehicles.

\*To make Pancras Road southbound lane, No entry to any vehicle at Goodsway/Camley Street/Pancras Road (Bridge) junction, except for taxis and pedal cycles.

\*To ban the left and right turn into Pancras Road (South) from Goodsway and Pancras Road (Bridge), except for taxis and pedal cycles.

\*To ban the left and right turn into access road from Pancras Road

(South. \*To prohibit all vehicles, except taxis from entering or travelling in the taxi lane adjacent to Pancras Road.

\*To make 'at any time' waiting and loading restrictions in Pancras Road
