

IF THE ORDER IS MADE, the stopping up will be authorised only in order to enable the development described in the schedule to this notice to be carried out in accordance with the planning permission granted by Wychavon District Council on 16th February 2006 under reference W/05/01525/AC.

The proposed Order will require improvements of areas of highway, and the provision of new highways maintainable at the public expense for which Worcestershire County Council will be the local highway authority.

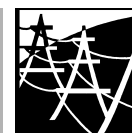

Notice is hereby given that Peel Environmental Ince Limited (Reg No. 5683333) (the "Company") (whose registered office is Peel Dome, The Trafford Centre, Manchester, M17 8PL), has submitted further information to the Department for Business Enterprise and Regulatory Reform ("BERR") in relation to its application for consent and deemed planning permission for the construction and operation of a RDF Plant (the "Original Application").

The Original Application was submitted on 30 January 2006 for:

"a proposal for the construction and operation of a refuse derived fuel plant, including landscape/ecological mitigation and vehicular access from Kemira Road, water access via an upgraded berth facility on the Manchester Ship Canal and rail access via an existing rail spur on land adjacent to the Manchester Ship Canal, Ince, Cheshire submitted by Peel Environmental Ince Limited"

The Original Application is currently on appeal (Planning Inspectorate reference APP/Z0645/A/07/2037113/NWF). On 26 July 2007 the Company submitted amendments to the Original Application, consequent to which the development description is:

"Construction and operation of a refuse derived fuel plant with associated buildings and infrastructure, and including area of hard surfacing, landscape/ecological mitigation and vehicular access from Kemira Road, erection of acoustic barriers, creation of cycle/pedestrian access from Station Road, water access via an upgraded berth facility on the Manchester Ship Canal and rail access via new rail link to an existing spur together with the provision of ecological mitigation areas and landscaping on land adjacent to the Manchester Ship Canal, Ince, Cheshire"

On 12 September 2007 BERR wrote to the Company's agent and stated its view that the amendments are minor in nature.
