NOTICE IS HEREBY GIVEN THAT THE Secretary of State for Transport has made an Order on the A30 Trunk Road in the District of North Cornwall in the County of Cornwall under Section 14(1)(a) of the Road Traffic Regulation Act 1984, because works are proposed to be executed on that road.

The effect of the Order will be to impose

(a) impose a 50 miles per hour temporary mandatory speed limit on the A30 from a point 1200 metres west of Kennards House Interchange overbridge to a point 500 metres east of Pennygillam Interchange underbridge;

(b) to authorise the closure of the A30 westbound exit slip road at Trebursye Interchange;

(c) to authorise the closure of the westbound carriageway of the A30 from a point 1000 metres east of Trebursye Interchange underbridge to a point 200 metres east of Kennards House Interchange overbridge, allowing for a contraflow on the eastbound carriageway.

(d) authorise the closure of the lay-by adjacent to:

(i) the westbound carriageway of the A30 situated approximately 600 metres west of the centre of the Trebursye Interchange; and (ii) the eastbound carriageway of the A30 situated approximately 800

metres west of the centre of the Trebursye Interchange These measures will be in the interests of road safety while contractors

carry out road renewal works. The order will come into force on 26 October 2007 and have a

maximum duration of eighteen months. However, it is expected that the works will take place between 28 October 2007 and the end of December 2007.

During the closure of the westbound exit slip road described at (b) above, traffic will be diverted to continue westbound to Kennards House interchange. Traffic will then leave the A30 via the exit slip road and take the unclassified road to Trebursye through Tregadillet. The temporary mandatory speed restriction, carriageway closures, layby closures, slip road closure and contraflow will be clearly indicated by traffic signs throughout the works period and will only apply when traffic management measures are in place.
