#### **INTEGRATED POLLUTION PREVENTION AND CONTROL**

Notice is hereby given that PZ Cussons (UK) Limited has applied to the Environment Agency for an Integrated Pollution Prevention and Control (IPPC) permit to operate an installation involving the production of a surface active agent. The installation is located at Agecroft Commerce Park, Swinton, Manchester M27 8UJ in the Borough of Salford, in the County of Lancashire.

The application contains the information required by the regulations including a description of any foreseeable significant effects of emissions from the installation on the environment.
