#### **THE HARINGEY (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (NO. 1) (AMENDMENT (NO. 55) ORDER 2007**

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Haringey, hereinafter called the Council, on **22nd November 2007** made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:

- (a) to reduce the time restrictions of the existing Green Lanes Zone A controlled parking zone from 8a.m. to 10p.m. Mondays to Sundays to 8a.m. to 6.30p.m. Mondays to Saturdays.
- (b) to reduce the time restrictions of the existing Green Lanes Zone B controlled parking zone from 8a.m. to 6.30p.m. Mondays to Saturdays to 8a.m. to 6.30pm, Mondays to Fridays.
- (c) to alter the use of some of the existing parking places within the existing Green Lanes Zone A & B controlled parking zones.

3. The further effects of the Orders would be:-

- (a) to alter the free parking places located in sections of the roads listed in the Schedule 1 to this notice, to residents parking places, operative between 8.00 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive, where vehicles displaying a valid residents parking permit or a disabled person's badge would be permitted to wait without time limit;
- (b) to alter the free parking places located in sections of the roads listed in the Schedule 2 to this notice, to residents parking places, operative between 8.00 a.m. and 6.30 p.m. on Mondays to Fridays inclusive, where vehicles displaying a valid residents parking permit or a disabled person's badge would be permitted to wait without time limit;
- (c) to alter the free parking places located in sections of the roads listed in the Schedule 3 to this notice, to shared residents and pay & display parking places, which operate between the hours of 8 a.m. and 6.30 p.m. Mondays to Saturdays inclusive, where vehicles would be permitted to wait for a maximum period of two hours at a cost of £0.70p for each 30 minute period or where vehicles displaying a valid residents parking permit or a disabled person's badge would be permitted to wait without time limit;
- (d) to alter the free parking places located in sections of the roads listed in the Schedule 4 to this notice, to shared residents and pay & display parking places, which operate between the hours of 8 a.m. and 6.30 p.m. Mondays to Fridays inclusive, where vehicles would be permitted to wait for a maximum period of two hours at a cost of £0.70p for each 30 minute period or where vehicles displaying a valid residents parking permit or a disabled person's badge would be permitted to wait without time limit;

4. Copies of the Orders, which will come into operation on **24th December 2007** the Orders being amended, of the Council's statement of reasons for making the Orders, together with plans and more detailed particulars showing the locations and effects of the Orders may be inspected during normal office working hours, until

the end of six weeks from the date on which the Orders were made, the Council decides not to make the Orders, The Traffic and Road Safety Group, 1st Floor (South), River Park House, 225 High Road, Wood Green, London N22 8HQ.

5. Any person desiring to question the validity of the Orders or of any provision contained therein on the grounds that they are not within the relevant powers of the Road Traffic Regulation Act 1984, or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

#### **THE HARINGEY (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (NO. 1) (AMENDMENT) (NO. 56) ORDER 2007**

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Haringey, hereinafter called the Council, on **22nd November 2007** made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to:-

- (a) alter the use of some of the existing parking places within the existing Wood Green Inner and outer controlled parking zones;
- (b) to vary some of the existing parking places within the existing Outer Zone Wood Green controlled parking zone.
- (c) to alter the Inner Zone to include sections of the streets listed in Schedule 1 to this Notice which were previously listed in the existing Wood Green Outer Controlled Parking Zone.
- (d) to alter the Outer Zone to include sections of the streets listed in Schedule 2 to this Notice which were previously listed in the existing Wood Green Inner Controlled Parking Zone.

3. The further effects of the Orders would be:-

- (a) to designate pay & display parking places operative between 8 a.m. and 6.30pm on Mondays to Saturdays inclusive, on certain lengths of Lordship Lane, N22 between Winkfield Road and Acacia Road, where vehicles would be permitted to wait for a maximum period of two hours at a cost of £1.10p for each 30 minute period or where a disabled person's badge would be permitted to wait without time limit;
- (b) impose waiting restrictions operative at any time, on certain lengths of the streets specified in Schedule 3 to this Notice.
- (c) to alter the existing free parking places located in sections of the roads listed in the Schedule 4 to this notice, to pay and display parking places, which operate between the hours of 8 a.m. and 6.30 p.m. Mondays to Saturdays inclusive, where vehicles would be permitted to wait for a maximum period of two hours at a cost of £1.10p for each 30 minute period or where a disabled person's badge would be permitted to wait without time limit;
- (d) to alter the existing free parking places located in sections of the roads listed in the Schedule 5 to this notice, to pay and display parking places, which would operate between the hours of 8 a.m. and 10 p.m.
