ROAD TRAFFIC REGULATION ACT 1984 – SECTION 14(1) (AS AMENDED)

TERMINAL 4 – ROAD NETWORK

TEMPORARY (FORECOURT REDEVELOPMENT) (NO. 02) ORDER 2007

Heathrow Airport Limited hereby give notice that to facilitate construction works they intend to make an Order, the effect of which would be to:-

- 1. Prohibit vehicles from entering of proceeding into any length of Stratford Road (outer lane)
- 2. Create permit holder only bays on the north-western side of Salisbury Road (third lane from the terminal) starting at the entrance to the lane and running for a distance of fifty two metres in a north-easterly direction
- 3. Prohibit any vehicle except for buses and London hackney carriages from proceeding into any length of Salisbury Road (first two lanes from the terminal)
- 4. Prohibit vehicles from entering or proceeding in that length of Salisbury Road (outer lane).

The prohibition would apply from 31st December 2007 to 31st March 2008, or until said works are complete, whichever is earlier.

THE HEATHROW AIRPORT LIMITED (CROMER ROAD WEST) EXPERIMENTAL ORDER 2007

- 1. NOTICE IS HEREBY GIVEN that Heathrow Airport Limited on 12th December 2007 made the above mentioned Order under Sections 2, 6, 9, 10, 32, 45 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ('the Act'), as amended, and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.
- 2. The general effect of the Order will be to create permit holder only bays for the purposes of valet parking on the north-east side of the third lane of Cromer Road West on the Arrivals forecourt.

No Waiting At Any Time:-

CHISLEHURST ROAD, Bickley, the south east side, from a point 18.29m south west of the south western kerbline of Merrydown Way north eastwards to a point 18.29m north east of the north eastern kerbline of Merrydown Way.

MERRYDOWN WAY, Bickley, both sides, from the south eastern kerbline of Chislehurst Road south eastwards for a distance of 18.29m.

No Waiting between 8.00am and 6.30pm on Mondays to Saturdays inclusive:-

THE GLEN, Shortlands, (a) the south and west sides, from the western kerbline of Shortlands Road to a point 7.5m south of a point opposite the party wall of Nos. 1 & 3; (b) the north and east sides, from the western kerbline of Shortlands Road to a point 6m south of the party wall of Nos. 1 & 3.
