EMMS PASSAGE, KINGSTON

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames on 10th December 2007 made the following Orders under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended:-

- The Kingston upon Thames (Prescribed Routes) (No. 4) Traffic Order 2007; and

- (a) Prohibit vehicles from entering or proceeding in Emms Passage (except for the purpose of gaining access for certain purposes);
- (b) Impose "at any time" waiting restrictions along the entire length of Emms Passage.

THE KINGSTON UPON THAMES (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. *) TRAFFIC ORDER 200* EXEMPTIONS FROM WAITING RESTRICTIONS FOR LOADING PURPOSES

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames propose to make the above Order under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Order would be to revise the provisions of the Kingston upon Thames (Waiting and Loading Restriction) (No. 1) Order 2006, so that vehicles would be permitted to wait on "yellow line" waiting restrictions throughout the Borough for the purposes of delivering or collecting goods or loading or unloading a vehicle for a period of forty minutes during the restricted hours.

This replaces the existing exemption which allows vehicles to wait for as long as may be necessary for such purposes before 11 a.m. and after 6.30 p.m., and for twenty minutes between 11 a.m. and 6.30 p.m. (during the restricted hours).

3. The proposed Order, and other documents giving more detailed particulars of the proposals, are available for inspection until 6 weeks have elapsed from the date on which either the Orders are made or the Council decides not to make the Orders at:

REVISED LAYOUT OF PARKING FACILITIES, HIGH STREET & THE BITTOMS, KINGSTON

1. NOTICE IS HEREBY GIVEN that the Council of the Royal Borough of Kingston upon Thames on 10th December 2007 made the following Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended:-

- The Kingston upon Thames (Parking Places) (Kingston) (Amendment No. 18) Traffic Order 2007;
- The Kingston upon Thames (Free Parking Places) (Disabled Persons) (Special Parking Area) (Amendment No. 38) Traffic Order 2007; and
- The Kingston upon Thames (Coach Parking Place) (Special Parking Area) (Amendment No. 5) Traffic Order 2007.

2. The general effect of the Orders, which will come into force on 17th December 2007, will be to:-

(a) introduce a bus parking place on the east side of High Street (outside Kingston Police Station, at which buses only (vehicles carrying 8 passengers or more) may be left for a maximum period of thirty minutes "at any time". The parking place would replace the existing bus stop clearway at this location;

(b) replace the metered parking bays on the east side of High Street (south of Kingston Police Station) with two disabled persons' parking bays. Vehicles displaying a valid disabled person's parking badge may be left in the bays without time limit during the permitted hours (between 8.00 a.m. and 10.30 p.m. throughout the week);

(c) remove the two metered parking bays on the west side of The Bittoms (opposite Drapers Car Park) to facilitate the introduction of a bus stop clearway (for use by buses on route 371) at this location. Please note that the existing bus stop clearway/standing facilities on the north side of Kingston Hall Road would also be extended.
