The general effect of the two orders would be respectively to install: A controlled parking zone operating from 9am. to 7pm. on Mondays to Fridays inclusive, comprising—

 (a) Designated parking places in: Bowness Road, Elmer Road, Engleheart Road, Jutland Road, Laleham Road south of Brownhill Road, Sangley Road, Shorndean Street and Sportsbank Street;
(b) Provisions will be—

(i) predominantly residents' parking places throughout; with

(ii) some shared use parking places for any permit holder or pay-anddisplay up to all day parking at Elmer Road north and south sides eastern and western end, Sangley Road north side western end and south side eastern end;
