- (i) the northern east to west arm, the north side, from a point 7.3 metres west of the western wall of Nos. 1 to 27 Queens Terrace westward for a distance of 4.9 metres and with a width throughout of 5 metres:

- (ii) the northern east to west arm, the north side, from a point 6.4 metres west of the western wall of Nos. 1 to 27 Queens Terrace eastward for a distance of 47.5 metres.
- (c) designate a "shared use" (pay and display and permit holders) parking bay in St. Stephen's Road E6, the south side, from the common boundary of Nos. 78 and 80 St. Stephen's Road to the common boundary of Nos. 86 and 88 St. Stephen's Road;
 (d) designate "permit holder only" bays in the following lengths of
- Tolpuddle Avenue E13:
- (i) the east side, from a point 1.8 metres north of the common boundary of Nos. 8 and 10 Tolpuddle Avenue northward for a distance of 12.9 metres:
- (ii) the west side, from a point 6 metres south of the southern kerbline of Queen's Road southward for a distance of 18 metres
- 5. The general effect of the Newham (Green Street) (Parking Places) (Special Parking Area) (No. 1, 2000) (Amendment No.) Order 200 would be to further amend the provisions of the Newham (Green Street) (Parking Places) (Special Parking Area) (No. 1) Order 2000 so as to amend the designation of parking places in lengths of Green Street E7 (between St. George's Road E7 and Tudor Road E6) to reflect the current marked locations of the parking places on the
- 6. The general effect of the Newham (Loading Bays) (No. 1, 2000) (Amendment No.) Order 200 would be to further amend the provisions of the Newham (Loading Bays (No. 1) Order 2000 so as to:
- (a) omit loading bays in Green Street E7, outside Nos. 212/214; Nos. 11 to 13 Carlton Terrace, Green Street; Queens Road E13 and Shaftesbury Road E7;
- (b) amend the designation of loading bays in Boleyn Road E7, Cromwell Road E7, King's Road E6, Neville Road E7, Park Road E6, Upton Park Road E7 and Woodstock Road E7 to reflect the current marked locations of the loading bays on the ground;
- (c) designate a loading bay in Harold Road E13, the north side, from a point 24.4 metres west of the western kerb-line of Green Street westward for a distance of 9.1 metres for use by vehicles for loading and unloading only operating 7.00am to 6.30pm every day of the week, providing continuous loading is taking place.
- 7. The general effect of the Newham (Waiting and Loading Restriction) (Special Parking Area) (Amendment No.) Order 200 would be to:
- (a) introduce restrictions on waiting by vehicles (except for loading or unloading purposes) operating 8.00am to 8.00pm on Mondays to

- Saturdays inclusive in St. Stephen's Road E6, the north-west to southeast arm (to the rear of Nos. 1-20 St. Stephen's Parade);
- (b) introduce restrictions on waiting by vehicles (except for loading or unloading purposes) operating 8.00am to 6.30pm on Mondays to Saturdays inclusive in Plashet Grove E6, both sides, between the southwestern kerb-line of Whitfield Road and a point 9.1 metres south-west of the south-western kerb-line of Fry Road;
- (c) introduce restrictions on waiting by vehicles (except for loading or unloading purposes) operating 'at any time' (double yellow lines) in the east to west arm of Florence Road E6;
- (d) introduce restrictions on waiting by vehicles (except for loading or unloading purposes) operating 'at any time' (double yellow lines) in the following lengths of King's Road E6:
- (i) the north-east to south-west arm, the south-east side, from a point 1.3 metres south-west of a point opposite the northernmost wall of Nos. 41 to 57 Kings Road to its junction with the northern east to west arm of Kings Road;
- (ii) the northern east to west arm
- (a) the north side, from the western kerb-line of the north to south arm of Kings Road westward for a distance of 7.2 metres;
- (b) the south side;
- (iii) the north to south arm;
- (iv) the north-west to south-east arm, the south-west side, from its junction with the east to west arm of Florence Road E6 to its junction with the east to west arm of Kings Road;
- (v) the southern east to west arm, the south side, from its junction with the north-west to south-east arm of Kings Road to a point 1.6 metres west of the common boundary of Nos. 37 and 39 Kings Road.
- 8. The general effect of the Newham (Prohibition of Stopping Outside Schools) (No. 2, 1993) (Amendment No.) Order 200 would be to further amend the provisions of the Newham (Prohibition of Stopping Outside Schools (No. 2) Order 1993 so as to omit redundant school keep clear markings in:
- (a) St. Stephen's Road E6, the south side, from the common boundary of Nos. 90 and 92 St. Stephen's Road eastward for a distance of 38 metres (to be replaced by a 'shared use bay' as set out in paragraph 4 (c) above):
- (b) Whitfield Road E6, the east side, from a point 11 metres south of the southern kerb-line of St. Stephen's Road southward for a distance of 27 metres (to be replaced by a 'children keep clear marking' as set out in paragraph 9 below).
- 9. The general effect of the Newham (Prohibition of Stopping Outside Day Nurseries) (No.) Order 200 would be to introduce "children keep clear" restrictions operating between 7.30am and 6.30pm on Mondays to Fridays inclusive on the east side of Whitfield Road E6 outside St. Stephen's Children's Centre.
