RELATING TO STATION ROAD, BELMONT

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Sutton proposes to make the above Order under sections 6 and 124 of, and Part IV of Schedule 9 to, the Road Traffic Regulation Act 1984, as amended by the Local Government Act 1985 and the Road Traffic Act 1991.

2. The principal objective of the Order is to compensate for the loss of parking provision as a result of the proposal published on 18 July 2007 [Reference FR618] to introduce bus stop clearways outside Deacon House and outside California Close.

3. The general effect of the Order will be to amend the limited time parking bays in Station Road, Belmont where ‘waiting is limited to 2 hours with no return within 2 hours’ operating ‘between 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive’ so as to:-

- introduce a parking place on the north side outside Nos. 7 to 11 with a notional capacity of 3 vehicles; and
- extend the length of the existing parking place on the north side outside Nos. 17 to 23.

- the draft Order;
- a plan showing the locations and extents of the proposals; and
- the Council’s Statement of Reasons for proposing to make the Order.
