THE EALING (WAITING AND LOADING RESTRICTION) (SPECIAL PARKING AREA) (AMENDMENT NO. 334) ORDER 2007

THE EALING (FREE PARKING PLACES) (NO. 2) (AMENDMENT NO. 95) ORDER 2007

- 1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council, in connection with a controlled parking zone for the Boston Manor area, on the 13th December 2007 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.
- 2. The general effect of the Ealing (Boston Manor) (Residents Parking Places) Order 2007 will be to :

(a) introduce parking places for the use by residents, their visitors and business users in lengths of Boston Vale, Cawdor Crescent, part of Clitherow Avenue, part of Haslemere Avenue, Southdown Avenue, Wellmeadow Road and Westlea Road;

- (b) provide that the parking places will operate between the hours of 10am and 11am and between 2pm and 3pm on Mondays to Fridays inclusive (the controlled hours);
- (c) provide that passenger vehicles, goods carrying vehicles, motorcycles and disabled persons vehicles may be left in a parking place without limitation on time during the controlled hours and that with the exception of motorcycles and disabled persons vehicles, a valid GG zone permit or voucher must be displayed whilst parked therein.
- 3. The general effect of the Ealing (Parking Places) (Pay and Display) (Boston Manor) Order 2007 will be to.
- (a) introduce 2 hour maximum stay "shared use/pay and display" parking place operating between the hours of 10.00 am and 6.00 pm on Mondays to Fridays inclusive in a length of Wellmeadow Road;
- (b) provide that passenger vehicles, goods carrying vehicles, motorcycles and disabled persons vehicles may be left in the parking places and that with the exception of motorcycles and disabled persons vehicles, a valid GG zone residents permit or a parking ticket purchased from a parking ticket machine must be displayed whilst parked in the parking place:
- (c) provide that no vehicle may return to the same parking place for a period of at least one hour in respect of vehicles where parking tickets purchased from parking ticket machines have been displayed, but that parking will have no limit on time for residents displaying a valid residents permit;
- (d) provide that the charges for parking in the 2 hour "shared use/pay and display" parking place referred to in paragraph 3 will be from 30p for 30 minutes (minimum) to £1.20 for 2 hours (maximum).
