The general effect of the Ealing (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. 334) Order 2007 will be to amend existing waiting restrictions or introduce new waiting restrictions that apply at any time or between the controlled hours in lengths of Boston Vale, Cawdor Crescent, Clitherow Avenue (between Haslemere Avenue and Cawdor Crescent), Haslemere Avenue (between Boston Road and Clitherow Avenue), Southdown Avenue, Wellmeadow Road and Westlea Road

5. The general effect of the Ealing (Free Parking Places) (No. 2) (Amendment No. 95) Order 2007 will be to introduce limited time free parking places in lengths of Cawdor Crescent and Haslemere Avenue where parking by vehicles between 8am to 6.30pm on Mondays to Saturdays will be limited to 30 minutes with no return by the same vehicle to the same parking place for a period of one hour.

6. Business Parking Permits will be available at a cost of £250 per annum and Residents Parking Permits at a cost of £25 per annum.

7. Business Visitors Vouchers will be available at a cost of £1 per hour and Residents Visitors Vouchers will be available at a cost of 80p for use during two separate visits. Borough wide vouchers will be available to park in the zone at the rate of £1 per hour.

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing Council, in connection with a proposed controlled parking zone for the Buxton Gardens area, on the 13th December 2007 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by the Local Government Act 1985.

2. The general effect of the Ealing (Buxton Gardens) (Residents Parking Places) Order 2007 will be:

(a) to introduce parking places for the use by residents, their visitors and business users in lengths of Barlow Road, Buxton Gardens, Chatsworth Gardens, Lexden Road and Rosemont Road;

(b) to provide that the parking places will operate between the hours of 9 am and 10am and between 3 pm and 4pm on Mondays to Fridays inclusive (the controlled hours);

(c) to provide that passenger vehicles, goods carrying vehicles, motorcycles and disabled persons vehicles may be left in a parking place without limitation on time during the controlled hours and that with the exception of motorcycles and disabled persons vehicles, a valid FF zone permit or voucher must be displayed whilst parked therein.

3. The general effect of the Ealing (Parking Places) (Pay and Display) (Buxton Gardens) Order 2007 will be to :

(a) introduce 2 hour maximum stay "shared use/pay and display" parking places operating between the hours of 9.30 am and 5.30 pm on Mondays to Fridays inclusive in lengths of Lexden Road;

(b) provide that passenger vehicles, goods carrying vehicles, motorcycles and disabled persons vehicles may be left in the parking places and that with the exception of motorcycles and disabled persons vehicles, a valid FF zone residents permit or a parking ticket purchased from a parking ticket machine must be displayed whilst parked in the parking place;

(c) provide that no vehicle may return to the same parking place for a period of at least one hour in respect of vehicles where parking tickets purchased from parking ticket machines have been displayed, but that parking will have no limit on time for residents displaying a valid residents permit;

(d) provide that the charges for parking in the 2 hour "shared use/pay and display" parking places referred to in paragraph 3 will be from 60p for 30 minutes (minimum) to £2.40 for 2 hours (maximum).

4. The general effect of the Ealing (Free Parking Places) (Disabled Persons) (Amendment No. 74) Order 2007 will be to introduce free parking places for vehicles displaying the disabled driver's blue badge parking permit without limit on time in a length of Lexden Road

5. The general effect of the Ealing (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. 333) Order 2007 will be to amend existing waiting restrictions or introduce new waiting restrictions that apply at any time or between the controlled hours in lengths of Barlow Road, Buxton Gardens, Chatsworth Gardens, Lexden Road and Rosemont Road
