London Borough of Lambeth PROPOSED WAITING RESTRICTIONS IN DREWSTEAD ROAD

(Note: - This notice is about the proposal to impose a new length of "at any time" waiting restrictions on vehicles in Drewstead Road. Objections or other representations may be made - see paragraph 6 below.

- 1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Lambeth propose to make the Lambeth (Waiting and Loading Restriction) (Special Parking Area) (Amendment No. -) Order 200, under sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.
- 2. The general effect of the Order would be to ban waiting by vehicles at any time (impose double yellow lines) on the south side of Drewstead Road, outside Nos. 27 to 35 Drewstead Road. (about halfway along the frontage of No. 27) instead of the existing ban on waiting by vehicles that currently applies in that length of road between 8 am and 6.30 pm on Mondays to Saturdays inclusive.
- 3. The Order is necessary to prevent parking at and near an island site and so ensure the safe and effective flow of traffic.

NEW ROADS AND STREET WORKS ACT 1991 SECTION 58 NOTICE OF SUBSTANTIAL WORKS FOR ROAD PURPOSES

- 1. Three months advance notice is hereby given that Transport for London intends to carry out substantial works for road purposes
- 2. The roads in which these works will take place, in the City of
- (a) The A41 Park Road/Prince Albert Road roundabout;
- (b) The junction of A202 Vauxhall Bridge and Millbank, including 40 metres north-east into Millbank, 90 metres south-east onto Vauxhall Bridge, 70 metres south-west into the north-east bound carriageway of Grosvenor Road and 75 metres north-west into the south-east bound carriageway of Bessborough Gardens;
- (c) The A4 Knightsbridge from William Street to Hyde Park Corner.
- 3. TfL Ref SPST-TO-S58/2008/002.
- Works are expected to affect the carriageway.
- 5. Works are expected to commence on (a) 5 May 2008; (b) 15 September 2008 and (c) 30 June 2008.
- 6. Works are expected to be completed on (a) 20 June 2008; (b) November 2008 and (c) 15 August 2008.
- 7. The works at the above locations will include carriageway resurfacing; associated reconstruction work such as adjustments to the
- utility covers and kerbs, anti-skid surfacing and road markings.

 8. Subject to the exemptions in the Act and Regulations under it, no street works may be executed for a period of 12 months from completion of the works described in paragraph 7 without consent of Transport of London, which shall not be unreasonably withheld. Contact Point:
