STOPPING UP OF HIGHWAYS (COUNTY OF HERTFORDSHIRE) (NO.1) ORDER 2008

The Secretary of State for Transport hereby gives notice that, on the application of Dandara Ltd, she has made an Order under Section 247 of the above Act entitled "The Stopping up of Highways (County of Hertfordshire) (No.1) Order 2008" authorising the stopping up of an area of all-purpose highway land adjacent to the Former Kodak Site, Leighton Buzzard Road/Cotterells, Hemel Hempstead, Hertfordshire, HP1 1JZ to enable the existing pedestrian bridge (along with the vehicle access to the existing car park on site) to be removed, and a new pedestrian bridge link to be constructed across Leighton Buzzard Road to provide a better link to the town centre, to be carried out in accordance with the planning permission granted under Part III of the Act to Dandara Ltd by Dacorum Borough Council on 21 December 2006 under reference 4/02790/06/MFA.

INTEGRATED POLLUTION PREVENTION AND CONTROL

Notice is hereby given that Glenside Minerals Ltd has applied to the Environment Agency for an Integrated Pollution Prevention and Control (IPPC) permit to operate an installation involving the importation of inert excavated surplus construction material including blending and storage to be carried out at Bank End Quarry, Bank End Road, Finningley, Doncaster DN9 3AN in the Doncaster Metropolitan Borough in the county of South Yorkshire.

The application contains the information required by the regulations including a description of any foreseeable significant effects of emissions from the installation on the environment. This information is held in registers at the following locations:
