(b) remove shared-use (business and pay & display) parking space from outside Nos. 119 and 121 Stroud Green Road and provide additional shared-use (business and pay & display) parking space outside Nos. 127 and 137 Backstock Road. This would not result in the loss of any shared-use (business and pay & display) parking space. 3.
