THE LONDON BOROUGH OF MERTON (WAITING AND LOADING RESTRICTIONS) (AMENDMENT NO *) ORDER 200*

1. Notice is hereby given that the London Borough of Merton, after consulting the Commissioner of Police of the Metropolis, propose to make the above-mentioned Orders under sections 6, 45, 46, 49 and 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, and all other enabling legislation.

2. The general effect of the Orders will be:

(a) to introduce waiting restrictions at the times specified in the roads detailed in Schedule 1 to this notice;

(b) to introduce loading restrictions at the times specified in the roads detailed in Schedule 2 to this notice;

(c) to introduce pay and display parking bays in Kingston Road in the locations detailed in Schedule 3 to this notice, operating Monday to Saturday between 8.00 am and 6.30 pm inclusive, costing 80p per hour, maximum stay 2 hours, no return within 2 hours.

1. Notice is hereby given that the Council of the London Borough of Merton, after consulting the Commissioner of Police of the Metropolis, intend to make the above-named Orders under section 6 of the Road Traffic Regulations Act 1984, as amended, and all other enabling legislation.

2. The general effects of the Orders will be to introduce the following restrictions, applying on tennis event days at the All England Lawn Tennis Club:

(i) No person shall cause or permit any vehicle to stop or remain at rest on Church Road between its junction with St Mary's Road and its junction with Wimbledon Park Road between 8.30 am and 9.30 pm;

(ii) No person shall cause, or permit any vehicle to load or unload on Marryat Road between its junction with Marryat Place and its junction with Somerset Road between 8.30 am and 9.30 pm;

(iii) No person shall cause or permit any vehicle proceeding in a northerly direction on Church Road, London SW19 to turn right into Car Park Number 6 and Car Park Number 8 of the All England Lawn Tennis Club.
