**SCHEDULE - EXTENSION TO TODMORDEN CONSERVATION AREA**

The extension includes all land and buildings in six distinct areas including the following:

- The length of Burnley Road and the properties fronting it from and including the former cinema building on the west side, and numbers 48-180 and Pennine Lodge on the east side; Cobden Street and Queen Street; 2-44 Harehill Street; properties on Blind Lane (excluding the former depot), West Street, Albert Lane, Albert Street, Adam Street, Cowfold Street and the south side of Harley Street to its junction with Victoria Road; 4-36 Victoria Road; all properties on Gledhill Street, Adelaide Street, Back Byrom Street, Byrom Street, Hammerton Terrace; St. Joseph's Church, St. Joseph's Primary School and the Priory, and 2-6 and 10-62 (evens) and 21-35 (odds) Wellington Road; all properties on Bath Street, John Street, Raglan Street, Dalton Street and Crescent Street; 1-43 (odds) and 2-18 (evens) Eagle Street; the north side of Stansfield Road to its junction with Vale Street; 2 Vale Street; 5 Whiteplatts Street.
