HIGHWAYS ACT 1980 - SECTION 116 AND SCHEDULE 12

LAND ADJOINING 1 FORGE COURTYARD, CANON FROME, LEDBURY, HEREFORDSHIRE

Notice is hereby given that the County of Herefordshire District Council intend to apply to the Hereford Magistrates' Court sitting at Court House, Bath Street, Hereford on 8th September 2008 at 10.00 hrs for an Order under Section 116 of the Highways Act 1980 authorising the stopping up of the land adjoining 1 Forge Courtyard, Canon Frome, Ledbury, Herefordshire on the grounds that the same is unnecessary with reservation of rights of statutory undertakers in accordance with Part II of Schedule 12 of the Act. Any person to whom notice is required to be given under paragraph 1 of Schedule 12 of the Highways Act 1980, any person who uses the Highway and any other person who would be aggrieved by the making

of the Order have a right to be heard.
