Madrid, September 2.

N Express arrived laft Thursday with Advice, that the Remains of the Spanift Troops from Sicily landed at Barcelona on the 25th paft, to the Number of 12000 Men, with their Gentral the Marquels de Lede, who is expected To-Morrow at the Elcurial General Chacon is alfo arrived at Alicant with the few Troops which were left at Sardinia. On Tuesday last circular Letters were feat to all the Prelates of the Kingdom, withOrders to caufe publick Prayers to be made in their leveral Dioceffes, for the Prefervation of this Country from the Plague which rages at Marfeilles; and thele Prayers have been already begun in the Churches of this Town. Very great Preparations are continued for an Expedition, in which 54 Battallions of Foot and 60 Squadrons of Horfe and Dragoons will be employed; these Forces are drawn together and quartered between Seville and Malaga, and Transports are getting ready to take them on board with a large Train of Artillery, and Stores of Ammunition and Provisions. Pare of those Stores are ordered to be fent over forthwith to Ceuta, which makes it believed the Expedition is intended against the King of Morocco's Dominions. Sig. Pozzobueno, his Catholick Majefty's Ambaffadour to the King of Great Britain, being recovered from an Indifpolition that detained him here leve. ral Days, fet out the 31st past for Bilbao, in order to imbark there for Holland, whence he is to proceed to Hanover. Major Elring-ton, the Commanding Officer of the British Garrison in Gibraltar, having some Weeks fince bought and paid for 40 Bullocks for the Service of the Garrilon, with the Confent of Collonel Don Bartholomeo Ramos, who then commanded the Spanish Troops quattered in the Country neat Gibraltar, the present Comman-der of those Troops M. de Louvigny upon Application made to him by Major Elrington, refused to let them pass to the Town. Heteupoh Major Eltington fent hither an Officer to represent this to Collonel Stanhope, His Britannick Majefty's Minister, who com-municating it to the Marquels de Tó-lofa Secretary at War, he was affured by him, that the Marquels de Louvigny had no Orders for what he had done, that he would reprefent the Affair to his Catholick Majefty, and procure all the Satisfaction that could be defired a Accordingly two Days ago the Matquels delivered to Collonel Stanhope an Order for the Captain-General of Andalusia, commanding him not only to fuff r

the 49 Bullocks mentioned before to pals to Gibraltar, but also to permit the free Entry of all Sorts of Provisions, with a strict Order to maintain a friendly Correspondence with the Garrison for the future. The Duke of Leeds who came lately hither, having defired Leave to wait on the King at the Elcurial, to offer him his Services for the re-eftablishing of his Marine, and fent his Majefty a Plan upon that Subject ; his Catholick Maje-Ay has exculed himfelf from accepting his Offer, and therefore fent him Word that he would not have him give himfelf the Trouble of repairing to the Efcurial.
