

The Orders will make changes to the C1 zone of the Cricklewood Controlled Parking Zone, which operates Monday to Friday 10am to 11am. These changes will extend these operating hours in Ridge Road, Prospect Road, Prospect Place and Sunnyside so that the CPZ operates Monday to Friday 10am to 5pm in these roads. The changes will also convert certain free parking places to resident parking places outside Longberrys in Cricklewood Lane, convert an existing pay and display parking place in Lyndale Avenue to allow resident permit and visitor voucher use, and convert an existing dual use pay and display and business permit parking place in Somerton Road to also allow resident permit and visitor voucher use. In addition to this the existing waiting and loading restrictions on the Cricklewood Broadway between Depot Approach and Cricklewood Lane which currently prevent waiting and loading Monday to Saturday 7am to 7pm will now operate Monday to Sunday 7am to 7pm.

The Orders will come into operation on Monday 20th October 2008. Copies of the Orders, plans of the relevant areas and the Council's Statement of Reasons for making the Orders can be inspected between 9am and 5pm on Mondays to Fridays (Bank Holidays and Public Holidays excepted) for a period of 6 weeks from the date on which this notice is published at:

Any person wishing to question the validity of the Orders or any of their provisions on the grounds that it is not within the relevant powers of the Road Traffic Regulations Act 1984 or that any of the relevant requirements thereof or of any regulations made thereunder have not been complied with in relation to the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

### **THE BRENT (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 295) ORDER 2008**

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Brent on 13 October 2008 made the above-mentioned Orders under sections 6, 45, 46, 49 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 as amended by section 8 of and Part 1 of Schedule 5 to the Local Government Act 1985, the Parking Acts of 1986 and 1989 and the Traffic Management Act 2004.

2. The general effect of the 'Disabled Persons Parking Places' Order will be to:-

- (a) designate a disabled person parking place in Slough Lane specified in Schedule 1 to this Notice in which vehicles authorised by the Order may be left for any period without charge;
- (b) provide that the parking place will operate "at any time";
- (c) specify, in respect of the parking place, that disabled persons' vehicles displaying in the relevant position a disabled person's badge (commonly referred to as "the Blue") issued by any local authority under the provisions of the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000 may be left therein;
- (d) provide that certain vehicles may wait in the parking place in certain circumstances, e.g., to allow persons to board or alight (maximum 2 minutes), to load or unload (maximum 20 minutes), etc and
- (e) revoke the existing disabled parking place in Old Kenton Lane.

3. The general effect of the 'Parking Places Amendment' Orders will be to:-

- (a) designate parking places that will operate between 8.00 a.m. and 6.30 p.m. Mondays to Saturdays in certain lengths of the streets specified in Schedule 2 to this Notice;
- (b) specify that:-
  - (i) each parking place may be used, subject to the provisions of the Order, for the leaving during the permitted hours of such vehicles as are passenger vehicles, goods carrying vehicles or invalid carriages displaying a valid parking ticket or permit. Motor cycles park free;

- (ii) the maximum initial period for which a vehicle, displaying a valid parking ticket may be left during the permitted hours in the parking places specified in Schedule 2 to this Notice will be 2 hours;

- (iii) the charge for short term parking in the parking places specified in Schedule 2 to this Notice will be 30 pence for 20 minutes, 60 pence for 40 minutes, £1.50 for 1 hour and £3.30 for 2 hours, the tickets for which will be issued by pay and display meters;

- (iv) the interval before a vehicle may again be left in a parking place after the expiration of the period for which the initial charge was incurred will be 2 hours;

- (c) reduce in length and redefine existing pay and display parking place in association with the improvement of road safety in Old Kenton Lane.

4. The general effect of the Order will be further to amend the Brent (Waiting and Loading Restriction) Order 1979, so that:-

- (a) waiting by vehicles (including waiting for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited at any time in the lengths of streets specified in Schedule 3 to this Notice;

- (b) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited at any time in the lengths of streets specified in Schedule 4 to this Notice;

- (c) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) will be prohibited between 8.00 a.m. and 6.30 p.m. Mondays to Saturdays in the length of street specified in Schedule 5 to this Notice;

- (d) waiting by vehicles for the purpose of delivering or collecting goods or loading or unloading a vehicle for a period of more than 20 minutes in the same place will be prohibited between 11.00 a.m. and 6.30 p.m. throughout the week in the lengths of streets specified in Schedule 4 to this Notice and between 11.00 a.m. and 6.30 p.m. on Mondays to Saturdays in the length of street specified in Schedule 5 to this Notice;
- (e) the sale or offer for sale of goods from a vehicle will be prohibited (except on Sundays in the lengths of streets specified in Schedules 3 and 4) unless there is in force a valid licence issued by the Brent Borough Council or the goods are immediately taken into or delivered at premises adjacent to the vehicle from which the sale is effected;
- (f) the use of any vehicle or of any animal or the wearing of fancy dress or other costume, wholly or mainly for the purpose of advertising will be prohibited;

- (g) any existing prohibition on the waiting by vehicles, the sale or offer for sale of goods from a vehicle or the use of any vehicle or animal or the wearing of fancy dress or other costume wholly or mainly for the purpose of advertising in the lengths of streets specified in the Schedules to this Notice will be revoked.

5. A copy of each of the Orders, which will come into operation on 27 October 2008, of maps of the relevant areas, of the relevant Orders of 1979 and 2001 (and of the Orders which have previously amended those Orders), 1999 and 2003 can be inspected during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Orders were made at:-

- (a) The One Stop Local Office, Brent Town Hall, Forty Lane, Wembley, Middx, HA9 9HX; and
- (b) The One Stop Local Office, Brent House, 349-357 High Road, Wembley, Middx, HA9 6BZ.

6. Copies of the Orders may be purchased from the address mentioned in paragraph 5(b) above.

7. Any person desiring to question the validity of any of the Orders or of any provision contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder has not been complied with in relation to any of the Orders may, within six weeks of the date on which the Orders were made, make application for the purpose to the High Court.

### **SCHEDULE 1**

Disabled Person Parking Place (At any time)

SLOUGH LANE, the north-west side, from a point 3.30 metres north-east of the north-eastern kerb-line of Old Kenton Lane north-eastward for 11.00 metres.

### **SCHEDULE 2**

'Pay and Display' Parking Places (Max: Stay 2 hours, no return within 2 hours)

PARK LANE, the north-east side, from a point 15.20 metres north-west of the southern wall of Chesterfield House, Park Lane to a point
