- (e) ban waiting by vehicles between Midnight and 8 am Mondays to Fridays inclusive in that length of:- (a) Weaver Walk, which lies on (i) the west side, between a point 5.5 metres north of the northern wall of Weaver House and its northern extremity; (ii) the east side, between a point 36.7 metres north of the northern kerb-line of Chapel Road and its northern extremity; and (iii) the north side; (b) Chapel Road, the south side, between a point 1 metres west of the party wall of Nos. 3 and 4 The Pavement, Chapel Road and a point 5.5 metres west of the party wall of Nos. 34 and 36 Chapel Road.
- 3. Any existing bans on waiting by vehicles in the lengths of streets specified in paragraph 2 (a), (b), (c), (d) and (e) above will be revoked.

  4. The bans are necessary to prevent parking which obstructs access for emergency services vehicles and refuse collection vehicles and hinders the free flow of traffic.

- 2. The general effect of the Order will be to introduce waiting restrictions "no waiting at any time" at the junction of Beech Way with River Way, at the junction of River Way with Elm Close, and at the junction of Rivermeads Avenue with Byeways (all as specified in Schedule 1).
- 3. The Council will also introduce footway parking exemptions on the south-east side of Beech Way and the north side of River Way. Vehicles will be permitted to park within the marked areas, partly on the footway, along the lengths of road described in Schedule 2.
