NOTICE OF APPLICATION FOR AN ORDER

Network Rail Infrastructure Limited of Kings Place, 90 York Way, London N1 9AG, has applied to the Secretary of State for Transport under section 6 of the Transport and Works Act 1992, for an order authorising the compulsory acquisition of land and rights in land and the temporary use of land in connection with the proposed alteration and improvement of Reading Station and the railway and railway facilities to the east and west of the station

The application is not to be made subject to an environmental impact assessment.
