THE CROYDON (FREE PARKING PLACES) (DISABLED PERSONS) (NO. 1) TRAFFIC ORDER 2009

1. NOTICE IS HEREBY GIVEN that Croydon Council on 27 April 2009 made the above-mentioned Traffic Order under Sections 6 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, and all other enabling powers.

2. The general effect of the Croydon (Free Parking Places) (Disabled Persons) (No. 1) Traffic Order 2009 would be to:

(b) designate new parking places at which vehicles displaying a disabled persons' badge may be left without charge or time limit outside Nos. 175 and 177 Albert Road, South Norwood, (2 wheels up on kerb), outside No. 3 Beckford Road, Croydon, outside Nos. 32 to 66 Bracken Avenue, Shirley, outside Nos. 42 and 44 Brampton Road, Croydon, outside No. 4 Brantwood Road, South Croydon, outside Nos. 107 to 117 Castle Hill Avenue, New Addington, outside Nos. 28 and 30 Darcy Road, Norbury, outside No. 38 Everton Road, Croydon, outside No. 17 Keston Road, Thornton Heath, between Nos. 123 and 125/127 King Henry's Drive, New Addington, between Nos. 148/158 and 149/159 Longheath Gardens, Croydon, outside No. 54 Lyndhurst Road, Thornton Heath, outside Nos. 13 and 15 Lynwood Gardens, Croydon, outside No. 31 and 33 Nugent Road, South Norwood, outside Nos. 48 and 50 Richmond Road, Thornton Heath, (2 wheels up on kerb), outside No. 51 Stoats Nest Road, Coulsdon, opposite Nos. 24 and 26 Whytecliffe Road South, Purley, (converting a pay and display bay), outside No. 42 Windmill Grove, Croydon and outside No. 69 Windsor Road, Thornton Heath.

3. A copy of the Order which will come into operation on 5 May 2009 and of all associated Orders can be inspected during normal office hours on Mondays to Fridays inclusive until the end of six weeks from the date on which the Order was made, at the "Access Croydon Facility", Ground Floor, Taberner House, Park Lane, Croydon, Surrey.

Any person desiring to question the validity of the Order or of any provision contained therein on the ground that it is not within the relevant powers of the Road Traffic Regulation Act, 1984 or that any of the relevant requirements thereof or of any relevant regulations made there under have not been complied with in relation to the Order may, within six weeks of the date on which the Order was made, make application for the purpose to the High Court.

ALDERMAN'S HILL – PROPOSED CHANGES TO LOADING BAY AND PAY & DISPLAY PARKING PLACE

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Enfield ("the Council") proposes to make the Enfield (Parking Places) (Pay and Display) (Various Roads) (Special Parking Area)(No. *) Order 200* and the Enfield (Goods Vehicles Loading Bays) (Special Parking Area) (No. *) Order 200* under sections 6, 45, 46, 49, 51 and 124 of and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Orders would be to relocate a loading bay in Alderman's Hill from its current position adjacent to Sherwood House, Old Park Road, to outside No. 54 Alderman's Hill. The operating times (8am to 6:30pm on Mondays to Saturdays, where vehicles would be permitted to loading/unload for up to 20 minutes, and no return within 1 hour) would remain unaltered. This would entail the removal of 6.6 metres of Pay & Display parking provision outside No. 54 Alderman's Hill.
