#### **GOSWELL ROAD – RELOCATION OF PAY AND DISPLAY PARKING BAY**

#### **ROPEMAKER STREET – RELOCATION OF A TAXI PARKING BAY/ADDITIONAL LOADING RESTRICTION**

1. NOTICE IS HEREBY GIVEN that the Common Council of the City of London propose to make orders under section 6 and section 45 of the Road Traffic Regulation Act 1984.
2. The effect of the orders would be to:

- (a) extend the existing parking bay which lies south of the bus stop on the east side of Goswell Road. A loading area would be provided within the limits of that parking place;
- (b) reduce in length a taxi parking bay on the south side of Ropemaker Street; and
- (c) prohibit waiting by vehicles for the purpose of loading or unloading etc. at any time on the south side of Ropemaker Street, between Moor Lane and the revised location of the above taxi bay.

3. A copy of the proposed orders, of the Common Councils statement of reasons for proposing to make the orders and of plans showing the affected streets can be inspected during normal office hours on Monday to Fridays inclusive within a period of 21 days from the date on which this Notice was published at the Department of Planning and Transportation, Guildhall, London, EC2P 2EJ.
