#### London Borough of Ealing

#### PROPOSED 20 MPH SPEED LIMIT ZONE IN WOOD END GARDENS AREA WITH TRAFFIC CALMING MEASURES

#### THE EALING (20 MPH SPEED LIMIT) (NO. \*) TRAFFIC ORDER 200\*

1. NOTICE IS HEREBY GIVEN that the London Borough of Ealing ("the Council") propose to make the above mentioned Orders under section 84 of the Road Traffic Regulation Act 1984, as amended.

2. The general effect of the Speed Limit Order would be to introduce a 20mph speed limit in Acock Grove - so much as is public highway,

Bannister Close, Bedser Drive, Brasher Close, Cassandra Close, Clauson Avenue, Dimmock Drive, Dorchester Close, Dorchester Road, Halsbury Road East, Halsbury Road West, Hammond Close, Hapgood Close, Hemery Road, Hendren Close, Hutton Close, Keble Close, Killowen Avenue, Larwood Close, Lillian Board Way, Mary Peters Drive, Matthews Road, Merton Avenue, New Court, Ramsey Close, Reading Road, Ross Road, Russell Road, Tessa Sanderson Way, Wood End Close, Wood End Gardens, Wood End Lane (part), Wood End Road (part) and Wood End Way

3. FURTHER NOTICE IS HEREBY GIVEN that the Council under the powers of section 90c of the Highways Act 1980 propose to introduce:

(a) a series of sinusoidal round top road humps each with a nominal height of 75 mms and longitudinal width of 3.70 metres in

- Dorchester Road: outside No. 12 and outside Nos. 30 and 32;
- Reading Road: outside Nos. 94 and 96 and outside No.28;
- Clauson Avenue: outside Nos. 88 and 90, outside Nos. 76 and 78, outside No. 48, outside Nos. 32 and 34 and outside Nos. 2 and 4;
- Russell Road: outside No. 43;
