B. THE HOUNSLOW (WAITING AND LOADING RESTRICTION) (AMENDMENT NO. 11) ORDER 2009

1. NOTICE IS HEREBY GIVEN that the Council of the London Borough of Hounslow on the 6 July 2009 made the above-mentioned Orders under sections 45, 46 and 49 of the Road Traffic Regulation Act 1984 (as amended) and under sections 6 and 124 of and Part IV of Schedule 9 to the afore-mentioned Act of 1984 and the Traffic Management Act 2004

2. The general effect of the Orders would be extend the parking control in the lengths of Layton Road, Brentford from its junction with Ealing Road as specified in Schedules 1 and 2 to this Notice.

3. The general effect of the Parking Places Order would be to:

(a) designating additional shared use parking places on the highway specified in column 2 of Schedule 1 to this Notice at which charges

may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places;

(b) designating additional residents only parking places on the highway specified in column 2 of Schedule 2 to this Notice at which charges may be made by the Borough Council for vehicles authorised by the Order to be left in those parking places; and

(c) providing that the parking places would operate between 9.30am and 5.30pm on Mondays to Fridays (Christmas Day, Good Friday and Bank Holidays excepted).

4. The general effect of the Waiting and Loading Restriction Order would be to further amend The London Borough of Hounslow (Waiting and Loading Restriction) Order 2008 so that :

(a) waiting by vehicles (otherwise than for the purpose of delivering or collecting goods or loading or unloading a vehicle) would be prohibited:

(i) "at any time" throughout the week in the length of Layton Road as specified in Schedule 3 to this Notice;

(ii) between 8.00 am to 6.30 pm Mondays to Fridays inclusive in the length of Layton Road as specified in Schedule 4 to this Notice; and (iii) between 9.30 am to 5.30 pm Mondays to Fridays inclusive in the length of Layton Road as specified in Schedule 5 to this Notice.

(b) waiting by vehicles for the purposes of delivering or collecting goods or loading or unloading a vehicle for a period of more than 40 minutes in the same place would be prohibited in the streets or parts of streets referred to in sub-paragraph 3(a) above.

5. The prohibitions referred to in paragraphs 4(a) and 4(b) above, would not apply in respect of anything done with the permission or at the direction of a Civil Enforcement Officer or a police constable in uniform or in certain circumstances as outlined in the 2008 Order. The usual exemption relating to vehicles displaying a disabled persons' "Blue Badge" would apply.
